SUBJECT: Revocable Encroachment Permit - Gateway Professional Center

SUMMARY:

Gateway Professional Center has applied for a revocable encroachment permit for the purpose of constructing planter and brick pavers. The City Engineer recommends that the permit be granted.

BACKGROUND:

The area for which this request is being made consists of an area adjacent to County Assessors Parcel No. 006-05-1, 2. An area adjacent to H Street 2' \times 80.38' and an area adjacent to 12th Street 2' \times 160.40'. A 21' walkway of brick pavers shall be constructed along 12th Street as shown on the plans.

RECOMMENDATION:

The City Engineer recommends that the attached resolution be passed granting a recovable encroachment permit to Gateway Professional Center in the area and for the purpose outlined above.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:
That a revocable encroachment permit for the purpose of
Constructing Planter & Brick Pavers
is hereby granted to, whose, whose
address is as follows: 1717 "I" Street, Sacramento, CA 95814
The encroachment area is described as follows:
An area adjacent to County Assessors Parcel No. 006-05-1, 2. An area adjacent to H Street 2' x 80,38' and an area adjacent to 12th Street. 2' x 160.40'. A 21' walkway of brick pavers shall be constructed along 12th Street as shown on the plans.

This permit is granted subject to the "General Provisions - Revocable Encroachment Permit", which were adopted by the City Council in Resolution No. 77-611 dated October 4, 1977, and the hereinafter specified special conditions, if any. This permit shall be effective only after the applicant files with the Department of Finance of the City of Sacramento, the insurance certificates required by the General Provisions.

SPECIAL CONDITIONS

- 1. The permittee shall comply with all requirements of the City Planning Department, the Building Inspections Department, and the City Sign Ordiance.
- 2. The permittee is required to maintain, repair and replace any bricks which in the opinion of the Sidewalk Inspector, cause concern for the public safety.
