Subject: **Extension of Contract Between the City and Sacramento Regional Transit District to Provide Police Patrol Services**

**SUMMARY**

This report recommends that the City Council approve an amendment to the contract between the City and the Sacramento Regional Transit District for the purpose of providing police patrol services for the RT Metro System for the period of July 1, 1987 through June 30, 1989 for an amount not to exceed \$304,590.

**BACKGROUND**

On June 3, 1987, the City entered into an agreement with Sacramento Regional Transit District to provide police patrol services for the Regional Transit Metro System. The City and Regional Transit desire to extend the principal agreement for an additional year at a new rate based on the City's cost to provide the salaries and benefits of the officers.

**FINANCIAL DATA**

The extension of the contract between the City and SRTD provides for an amount not to exceed \$304,590 for police patrol services to the RT Metro System. This represents a total for the full contract period of \$664,560.

**RECOMMENDATION**

It is recommended that the City Council, by resolution, authorize the City Manager to execute an extension of the agreement between the City and SRTD for police patrol services for the RT Metro System.
