I. CALL TO ORDER - At the hour of 4:18 p.m. All Commissioners present.

II. APPROVE AGENDA OF JUNE 8, 1994 Moved: Yee; seconded: Burt Ayes: Unanimous

III. APPROVE MINUTES OF MAY 11, 1994 - Minutes approved as written. Moved: Burt; seconded: Yee Ayes: Unanimous

IV. PRESENTATION(S) - AB3598; A - Z INITIATIVE

Director Michelle Walker stated that the purpose of this presentation is to begin a dialogue on the possible options the A - Z Initiative offers the Arts Commission and to update the Commission and public on the Neighborhood Arts Program. Staff will present current and developing programs. As the Arts Commission is an organization serving the general public as well as artists and arts organizations, the Neighborhood Arts Program will serve to further bring the Arts Commission's programs to communities. Program changes will occur in order to develop and broaden the Neighborhood Arts Program, which serves all of the City Council and County Board districts. Five District Arts Advisory Committees (DAAC's) have been created. These committees will be made up of community members, educators, social services representatives and artists. A needs assessment will be done first, then published for artists,

Meeting Date:06-08-94 Page 1 of 5 arts organizations and service organizations to review. These groups will jointly propose programs which meet the needs of the assessment.

Ms. Walker noted that the Arts Commission applied for a grant from the NEA Locals Program, but did not receive funding, however, when applying to the CAC with the same proposal, it ranked a 4--the highest rank. The program is now considered a model for the State of California. Ms. Walker is speaking to other possible funders for this program as well. If the A - Z Initiative does pass, Walker proposed the Arts Commission ask the Council/Board to fund the Neighborhood Arts Program with the Regranting funds; if it doesn't pass, continue to fund the Regranting Program, as well as continue to seek additional funding sources for the Neighborhood Arts Program.

Two other programs, the Mentor and Incubator Arts projects will also become a part of the Neighborhood Arts Program. Staff will work closely with Friends of the Arts Commission to develop a mentor program with artists. APP currently has a Mentor Program that will provide more experience for local artists who may not otherwise have an opportunity to work with a major nationally-known artist. Should the A - Z Initiative pass through Friends, the Mentor Program could apply to receive additional funding. The Regranting Program will continue to fund individual artists.

An Incubator Arts Program would develop the managerial quality of organizations, which would lead to increased artistic quality as well; Houston, Texas has a similar program. Elected officials need to be kept abreast of the Arts Commission's options; staff and Commissioners are currently meeting with officials concerning the Neighborhood Arts Program and will go out into the neighborhoods this summer. A new Arts Commission brochure is being developed and a new issue of the <u>QuARTerly</u> is due out soon. These can also be used as tools to inform the public of the Arts Commission's programs and direction.

Walker turned the presentation over to Arts Program Coordinator Laurie Heller, who spoke about the implementation of the Neighborhood Arts Program and using the arts to address social issues. The program is designed for community members to work with the community-at-large (schools, parents, health & safety officials, churches, etc.)

Staff is now meeting with elected officials to develop DAAC's and, throughout the summer, will meet with individuals who may be interested in serving on committees. Committees will meet in October to identify needs and establish goals in each of the five districts. There will be winter workshops to get community feedback, then RFP's will be developed for the different neighborhoods. In Spring 1995, a panel process will convene to select artists and organizations for each district. The program will be conducted from May 1995 through December 1995. The program will have a pre- and post-evaluation component also. Heller then introduced other staff members, who spoke about existing programs and how they could be integrated into the Neighborhood Arts Program.

Arts Program Assistant Mario Moreno spoke regarding the research he has done on a mentorship program concept. Successful examples include the Oak Park Mural Project and the mentorship program in the Convention Center APP Project.

The mentorship program will enable emerging artists to heighten their expertise with an established artist. Artists will learn how to apply for grants, commissions, etc. This will be an intense one-on-one program between emerging and experienced artists. The program is planned for implementation in 1995.

Arts Education Consultant Victoria Plata spoke about the AIDS Rap Opera and Late Night Sacramento. The Rap Opera (in association with UCD Medical Center) started with Sacramento High School last summer; it will be rehearsed and performed at McClatchy High this summer. Peer-to-peer training for performing and visual artists will continue.

Late Night Sacramento currently has four sites and is partially funded by Kaiser Hospital and PG&E. There are opportunities for students to learn dance, vocal, and video art. Late Night Sacramento will begin June 13 in North Highlands, for the county. It is planned to expand this program with future funding.

Art in Public Places Consultant Nancy Esajian spoke about the Convention Center and its Mentorship Program. The local artists selected for mentorship will fly to the studio of the mentor artist to experience their artwork process and business practices. The mentor will select their own apprentice artists, which will provide for the development of the type of team needed to complete the project.

In April 1994, artist Sam Tubiolo designed a mural and planters for Ninos Park. Children from the area helped to make tiles. The intent is to build ownership of the park by community members. The project is planned for completion by mid-July.

Arts Program Assistant Kathy Gee spoke about the involvement of the Arts Commission with the City's Graffiti Abatement Program. The Arts Commission would like to be involved in positive alternatives to the problems of graffiti in the area. Staff will coordinate with the Neighborhood Services Department and work to have current murals cleaned regularly with help by volunteers. Staff is also working to secure public and private wall space for murals. APP Intern Lane Aldridge will work with Graffiti Abatement Coordinator Noel Eusebio on this. An anti-graffiti poster is being developed; Regional Transit is developing a Young Artist Program; staff is working on both projects in association with the Neighborhood Services Department and Regional Transit, respectively. Mr. Aldridge is also recruiting volunteers to be "our eyes" and help the City in dealing with graffiti.

Ms. Heller noted that each of these projects is tied to social issues being dealt with in the community. Ms. Walker commented that the Arts Commission wants to work with the artists so that they can input their own concepts for projects through the Neighborhood Arts Programs. Staff also wants to encourage health and social service organizations to work with artists in collaborative projects for youth. The Arts Commission has been transitioning to neighborhood-oriented and arts educational programming; these changes have provided more opportunities for artists to be hired and have been educational for the many agencies the Arts Commission now collaborates with. This concluded the staff presentations.

Priscilla Demo, a member of the public, asked about the implications to the Arts Commission if the A - Z Initiative passes; Director Walker noted that approximately \$10 million in funding will be available. Commissioner Burt asked about the possibility of disbanding the Arts Commission, if the Initiative passed; Walker noted that there are many options for the Arts Commission. In taking a pro-active position, the Arts Commission will continue to move forward with its Neighborhood Arts, Regranting, Art in Public Places and Arts Education programs. Commissioner Payne commented that it is not the intent of the initiative to disband the Arts Commission.

Commissioner Davis asked about the status of smaller organizations in the initiative; Commissioner Payne noted that negotiations are continuing and Chair Marquez noted that small organizations are included in the bill.

Commissioner Yep asked about non-profit application for funding. Director Walker said that the Arts Commission could apply for program funding through Friends of the Arts Commission as they are a 501(c)(3) non-profit organization, similar to the Crocker's, the Zoo's and the Library's non-profit organizations, which also have City and County staff.

Commissioner Kamilos noted that Friends could be a viable organization to apply for A - Z funding. Director Walker commented that the Arts Commission's funding is at the same level as the twelve/large organizations named in the A - Z Initiative. It is most important to focus on the Commission's vision for Sacramento County and the valuable programs that have been developed which serve the public. Commissioner Burt noted the positive feedback from the public on the Arts Commission's programs over the past year and a half.

V. PUBLIC TESTIMONY

Robbin Ware (California Cultural Assembly) thanked the staff and the Commission for its sensitivity to issues and for striving to obtain a balance in gender and ethnicity. Mr. Ware noted that he has attended some of the negotiation meetings for small arts organizations. He noted that the community needs the arts, but not at the expense of small organizations. There have been many persons who were instrumental in working to bring fair equity into the Initiative. Ware urged the Arts Commission to continue to remain sensitive to the needs of ethnic minority organizations, small organizations and the general public.

Buck Busfield (Fantasy Theatre) noted the Arts Commission has been of tremendous service to Sacramento and the region and expressed his enthusiasm for the Neighborhood Arts Program.

John Collentine complimented the staff on its presentation at today's meeting. Staff is proactive and looking ahead to the future. It is important to let the public know what the Arts Commission is and what it is doing in the community.

Director Walker acknowledged Commissioner Yee for her participation as a Commissioner, the Vice Chair, Arts Education and Outreach Committee Chair, and past APP Committee Chair. Ms. Yee has attended countless meetings with Council and Board to urge support of the arts. Chair Marquez acknowledged Commissioner Yee and noted his recollection of meeting Commissioner Yee at their first meeting. Sandra has been a very open and independent person and has taken on the most difficult tasks in committees. Yee thanked outgoing Chair Marquez for the past two years of leadership. Ms. Yee would like the next year to be characterized by open communication. Yee commented on her vision and stated that in reviewing the Powers and Duties of the Commission, she feels the staff and Commissioners are working towards and doing what is intended. Yee thanked the staff and Commissioners for their dedication to service and the job they do.

VII. CHAIR'S REPORT

On June 9, the CAC will be meeting at the State Capitol, 10 a.m. The Confederation will present Cultural Equity Initiative to the CAC at 2 pm (Susan Hoffman facilitator). The CAC will be making its State Local Partnership Program (SLPP) grant recommendations as well.

Mr. Marquez is aware of the A - Z negotiations and feels that there will be concrete changes to the Initiative as it now stands. Commissioner Yee noted an excellent turnout for the CSSSA students; Mrs. Wilson was in attendance to present awards. The Agency Orientation, presented by staff on May 26, was excellent; something to consider on a yearly basis, and also to service organizations.

VIII. DIRECTOR'S REPORT/PROGRAM UPDATE

CAC will be meeting tomorrow at 1:30; presentations will be made on local arts organizations. The Arts Commission will be highlighted at that time. The CAC is currently going through its yearly budget process; Commissioners are asked to write our State representatives to fund the CAC at 100%.

Director Walker will be attending a Multi-Cultural Tourism conference this Thursday, Friday and Saturday. Late Night Sacramento continues. Arts Commission component is in place; will work with County to expand the program.

IX. COMMITTEE REPORTS

Α. PERFORMING ARTS (Yep) - A - Z Initiative representative was not able to make the last meeting. Pat Davidson discussed the 1994 Sacramento Children's Festival (Old Sacramento and Downtown Plaza); attendance figures may approach 150,000. Arts Commission was well represented with the Artists' Showcase, Kodak Booth/APP tour. Commissioner Burt noted that the Festival drew a diverse population of the community. Secretary Karen Welch asked if there was any feedback from the Downtown Plaza merchants (first Children's Festival for the merchants since the Plaza's grand opening); Davidson has not received any feedback yet. VISUAL ARTS - No report. Ms. Walker stated that the Mission Statement and Goals are being revised and they will be presented to the Commission.

- ART IN PUBLIC PLACES (Tinnin/Esajian) Alice Aycock has been recommended as the mentor artist for the Convention Center project by the Artist Selection Panel and the APP Committee. She will recommend apprentice artists from local finalists. St. Rose of Lima Park project is scheduled for August Council meeting. Please note: There will <u>not</u> be a special meeting on June 15 as previously noted. Cavanaugh artists will present their proposal to the Committee at the July 20 APP meeting.
- D. ARTS EDUCATION AND OUTREACH (Yee) Arts Education Consultant Victoria Plata interviewed and hired Katie Thomas as the coordinator and curator for the Alamo Student Art Project. Four schools will participate in the first exhibit in November. Committee members will be meeting to develop an arts education component to be sent to area schools. Music component is being developed; music will be the focus for the 1995 Sacramento Children's Festival. Five hundred Cultural Resource Directories were given away at the 1994 Children's Festival. Two Artists' Showcase tents will be utilized for the 1995 Children's Festival. Thank you to Friends and volunteers for their help at the Arts Commission's booth.
- E. AWARDS (Heller) A new regranting cycle is due to begin; Cultural Awards guidelines and flyers were distributed to organizations. The second of two workshops will take place June 11 (Community Outreach & Building Boards). May 21 was the first workshop. California's Original Theatre Company expressed their thanks to the Commission and staff for the technical support provided.
- F. FUND AND ECONOMIC DEVELOPMENT (Kamilos) The Arts Commission's Orientation was the meeting for the Committee. The Committee will meet in July.

<u>SUMMARY</u>: This report describes the concurrent redesign process for construction of St. Rose of Lima Park and focuses of the Public Art Component of a video art installation by an Oakland artist Lawrence Andrews. The park is located on the northeast corner of 7th and K streets, across the street from the new Downtown Plaza Mall (see map, Attachment I). This report describes the preparatory research, includes a feasibility study of video artwork maintenance and provides information as to how the public art component and park redesign will be coordinated and implemented. BACKGROUND INFORMATION:

The Sacramento Metropolitan Arts Commission (SMAC) and the Sacramento Housing and Redevelopment Agency (SHRA) are jointly sponsoring a concurrent redesign of St. Rose of Lima Park, which includes installation of a major public artwork project.

MASTER PLAN CONSULTANT SELECTION:

SHRA released a Request for Qualifications (RFQ) for 1) the preparation of a conceptual park and mixed-use facility Master Plan, 2) the preparation of construction documents for the park only, and 3) the preparation of a graphics component for the park, Merchant Alley, and the K Street mall between 7th and 13th streets, in October 1993. This action resulted in the selection of Hargreaves Associates, an urban design firm from San Francisco, in December. This design team, which also includes, the office of Michael Manwaring (graphics), Thompson Associates (transportation architects), PSOMAS & Associates (civil engineering) and local civil, electrical and mechanical engineers, will design a park environment which will include a permanent or semi-permanent ice skating rink, with multi-purpose space for programming events, and potentially, an outdoor dining area, vendor areas, newsstand, and a ticket sales pavilion. The project also includes the preparation of a conceptual master plan, including transit-related amenities, for the adjacent Merchant Alley, as well as for the easterly one-quarter block bounded by J Street, 8th Street, and Merchant Alley.

VIDEO ARTIST SELECTION:

On December 9, 1993, SMAC released a RFQ for individual artists or an artist-led collaborative team to submit qualifications for design of a video art installation within

the park. The video installation which may be interactive, would be distinctive, highly durable, and disseminate visual imagery; it may also include audio component. The artist(s) commissioned will be expected to research, the history of the site and develop artwork which will be flexible enough to allow for collaborative design coordination with the SHRA urban design team.

The deadline for submission of all application materials was January 10, 1994, and the formal selection process included an artist selection panel composed of: Juan Carrillo, Deputy Director of the California Arts Council; George Hargreaves, Hargreaves Associates, urban design firm for SHRA; Robert R. Riley, Curator of Media Arts, San Francisco Museum of Modern Art; Jerry Takigawa, Photographer, Graphic Designer; Christine Tamblyn, Professor of Inter-disciplinary arts at CSUSF and Jean-Edith Weiffenbach, Director of Exhibitions and Public Programs, San Francisco Art Institute. The Technical Advisory component of the selection panel was composed of Michele Rudek, Landscape Architect, of Neighborhood Services Dept. (maintenance for St. Rose of Lima Park; Allan Lammers, Director of Sacramento Downtown Association and Freeman Tinnan, artist, arts educator, Chair of the APP Committee and Commissioner. On January 14, 1994 the panel reviewed all twenty (20) eligible submittals and selected three finalists to submit proposals for the park: Lawrence Andrews, Vito Acconci and Frank Video.

On March 4, 1994 at the Riverview Plaza at 600 I Street the Artist Selection panel

reviewed the three finalist's proposals and selected Oakland artist, Lawrence Andrews to execute the public artwork project. The public was invited to observe the three proposal presentations and were given three minutes for comments and questions after the selection panel's questions were answered by the artists.

COMBINED PROCESS:

The project timeline has been developed to integrate the park's redesign with the artwork design, selection and installation. The three commissioned artists and urban design professionals were required to meet both formally and informally at each of three public workshops and with City and SHRA staff in order to facilitate both the planning process and the finished work products. In addition, both consultants shall work with the Downtwon District to coordinate program needs related to the design of the park as well as to integrate the art component into the design, and with the SHRA technical advisory committee. In order to disseminate information on both the Master Plan and the public artwork project contract to all affected entities and commissions [APP, SMAC, Design Review/Preservation Board, SHRC, the Agency, and the City Council, staff will prepare a joint report and present it in accordance with the attached schedule. The combined schedule to produce and implement the St. Rose Master Plan, Graphics Program, construct the ice rink, multi-purpose space and install the video art project has been included as Attachment II to this report. Key milestones are highlighted. Finally, a copy of the SMAC RFQ, Attachment III and SMAC RFP, Attachment IV, are

included for your information.

FINANCIAL CONSIDERATIONS:

Funding for the St. Rose of Lima APP project was established in 1990 from administrative savings, St. Rose, Weinstock's and Regional Transit funds, which were placed in the APP Trust Fund (590). \$250,00 has bee allocated for the video art installation. Additional funding funding has been set aside for maintenance, stafff charges, and a feasibility study. Additionally the NEA has granted the city \$28,000 for the planning phase of the project.

POLICY CONSIDERATIONS:

The Artist Selection Process is in line with the APP Procedures as outlined by ordinance. The involvement of the public in the artist selection process is derived from the grant guidelines of the NEA Design Competition.

SUMMARY:

This Request for Proposals (RFP) is a/call to artists/craftspersons for three different sites in Phase I. Site C is located at the J Street entrance, and the artwork or monolith will be located under the awning and to the left. The commission amount is \$75,000. The monolith will be highly visible to people walking or driving by on

J Street. The RFP seeks an artist or artist led team to design, fabricate and install an artwork intended to be a marker for quests to meet one another and to humanize the scale of this enormous facility. The APP Committee and Artist Selection panel agreed that the artwork should be a significant piece with weight and presence. The competition is open to artists residing in the United States.

Site D is the Pocket Park located on J Street near the corner at 15th Street. This call seeks an artist to treat the gates and related site furnishings with artwork for a commission amount of \$50,000. To be treated are one large gate, two small gates and a fixed panel with a combined length of 24' and five decorative planters associated with the signage poles on the J Street sidewalk. The competition is open to artists residing in California.

Site E is in the Link Corridor on the second floor and connects the facility east to west. This call seeks an artist/craftsperson residing in the <u>eleven county</u> area to design, build and install exhibition display cases. The cases will be inset flush with the corridor walls at eye level and measure approximately 3-4'W x 4'H x 2'D. The display cases must have interior lighting and locking devices. This corridor will be place where visitors and local guests can experience exhibitions about Sacramento history and the arts. 650,000.

COMMITTEE ACTION:

The APP Committee approved the RFP at a special meeting on June 29, 1994 with a vote of 4 ayes, 0 noes and 5 absent.

BACKGROUND:

The concerns for each site focus on providing strong public art to serve the community as well as to address the cultural and gender equity issues of distributing Art in Public Places dollars.

There are two Phases to the Convention Center Expansion Project. Phase I involves five sites for artwork. The East Ballroom Lobby was the first, Sites A & B are the second and third with Sites C & D being the forth and fifth. Note that Site E, the Link Corridor, is actually part of Phase II construction, but the exhibition display cases must be designed during the timeline for Phase I.

BACKGROUND cont':

Phase II involves four sites with three remaining, due to an early call on Site E. Site F: \$30,000 K Street Lobby Screen will be open to artists residing in the eleven county area. Site G: \$30,000 K Street Lobby Wall will be open to artists residing in the United States. Site H: \$355,000 13th Street Pedestrian Path Sculpture Park. This area will provide many different sites and have opportunities for national, state and local artists.

FINANCIAL CONSIDERATIONS:

The overall Public Art budget for the Convention Center Expansion Project is \$960,000, with funding derived from the 2% allocation of the construction budget. The budgets for the three sites in this RFP, all in Phase I are as follows: Site C: \$75,000. Site D: \$50,00. Site E: \$50,000.

In process thus far in Phase I: East Ballroom Lobby; \$300,000 for a large suspended artwork: nationally recognized mentor artist; \$275,000, two local apprentices; \$10,000 each with \$5000 for their travel to mentor's studio. Site A: \$20,000 commission for two photographic murals (\$10,000 each) and is open to artists residing the nine adjacent county area. Site B: \$50,000 commission for artwork for the East Ballroom Terrace and is open to artists residing in the United States.

POLICY CONSIDERATIONS:

AGENCY

An integral part of most public and private construction, the APP Program has become well respected.

SACRAMENTO CONVENTION CENTER

The expansion of the Sacramento Convention Center will triple its size by adding 261,800 square feet. The unique architecture of the project will enhance the downtown urban landscape and provide a flexibile and technologically advanced facilty. CULTURAL AND GENDER EQUITY

The Artist Selection Panel and the Art in Public Places Committee seeks to commission artists in public art that will reflect our community's culturally diverse composition. To ensure that goal the overall Art Plan for the Convention Center Expansion Project has opportunities for many local artists, California artists and those artists nationally recognized as well.

Each commission site has specific eligibility requirements. Please carefully read eligibility requirements for each commission site and make sure the residency and other requirements are met.

CITY AND REGION OF SACRAMENTO

Known as the "River City," Sacramento is renown for its "Gold Rush" heritage, oak trees and arts and recreational amenities. Three major rivers are within the Sacramento county - the American, Cosumnes, and Sacramento. These rives established Sacramento as a major transforation artery with San Francisco and contributed to it being the west coast base for the Pony Express, telegraph and the Transcontinental Railroad. Just as in the past, agriculture contributes greatly to the area's economy with tomatoes, rice and almonds being the chief crops.

COUNTY OF SACRAMENTO

The county population is approximately 1.3 million and the city population is 370,000 according to the 1990 Census. The ethnic composition of the community is 69.3% Caucasian, 11.7% Latino/Chicano/Hispanic, 9% African-American, 8.8%

Asian/Pacific Islander, .9% Native American/Aleut, and 2% other. Sacramento county has 186 elementary schools, 33 junior high schools, 47 high schools, three community colleges, and one California State University

SITE C, SITE D and SITE E are opportunities for artwork at the Sacramento Convention Center. SITE C: J STREET ENTRY MONOLITH

COMMISSION AMOUNT: \$75,000

DESCRIPTION OF LOCATION AND ARTWORK POSSIBILITIES:

Please refer to the RFP map; ground level. The artwork at this location will serve as a marker to Convention Center visitors. This highly visible monolith will be a point of reference for people to meet before entering the building and will be visible to people passing by in vehicles.

The site for the monolith will be a restricted space under the J Street entrance awning. When facing the building, the artwork will be sited to the left of glass doors. The artwork will need to be contained in an area approximately 10' H and occupy no more than 2' in circumference. The monolith must be constructed of permanent materials that are intended for outdoor conditions.

ELIGIBILITY: Artists must reside in the United States

SITE D: POCKET PARK GATES AND RELATED SITE FURNISHINGS

COMMISSION AMOUNT: \$50,000.

DESCRIPTION OF LOCATION:

Please refer to RFP map; ground level. The narrow park is located on the northeast corner of the facility, and is next to the existing church at 15th and J streets. The J Street gates will be highly visible to people walking and driving by.

ARTWORK POSSIBILITIES

There are three gates to be treated with artwork. It is mandatory that the installation of the gates be completed by February 15, 1995. On the J Street side of the park there is a large gate; 16' W x 8' H, which adjoins a pedestrian gate; 3 1/2' W x 8' H, and also a small fixed panel 24" x 8'. The total length of the two gates and the fixed panel is 24'. At the back side of the park, a third gate 3 1/2' W x 8' H serves as access to the alley. Additionally for consideration, along the J Street sidewalk there are five decorative planters affixed to signage poles. These planters measure 16" in diameter, are 5 1/2' H, and near the top each planter flares out to 20 - 22" in diameter. The planters are affixed to the signage pole beginning about 6" off the ground.

SITE E: DISPLAY CASES FOR LINK CORRIDOR

DESCRIPTION OF LOCATION:

Located on the second level, the passageway links people from east to west portion of the faciloty. This area will be an excellent space for people to observe exhibitions.



SUMMARY:

An invitational letter from the Artist Selection Panel and the APP Committee invited approximately 50 artists to submit a letter of intent, resume and 3 slides for the mentor portion of this commission. Twenty-five (25) artists applied. The Artist Selection Panel voted unanimously to recommend artist Alice Aycock as the mentor artist with Agnes Denes and Kristina Lucas as alternates.

The Artist Selection Panel members were: Janet Bishop, SFMOMA, Albert Byrd, artist and educator, Karen Fenley, artist, Arthur Gonzalez, artist and educator, Caryl Henry, artist and curator, George Loschy, Principal Architect and Rich Murai, artist and educator. These panelists each had a separate vote and the following Technical Advisory members shared a collective vote: Jim Faber, Project Architect, Richard Raisler, APP designate, Susan Wurdeman, Project Design and Leonard Zirilli, Assistant Director of Community and Visit's Services.

Over 500 Request for Qualifications (RFQs) for apprentices were sent out with nineteen (19) responding for artists residing in Sacramento county. A short list of applicants were recommended by the Artist Selection Panel on May 16, 1994. The final selection of one male and one female apprentice by the mentor was built in to the process to ensure gender equity. On June 21, each apprentice finalist had a fifteen minute interview which included their personal narration of their ten artwork slides. Alice Aycock, proposed artist, Richard Raisler, APP designate and Nancy Esajian, APP consultant participated in the interviews. The selection of Maru Hoeber and John Tucker as apprentices was made by Aycock. Her selection was based upon the professional skills that each artist could bring to the team.

COMMITTEE ACTION:

On May 18, 1994 the APP Committee approved the May 16, 1994 Artist Selection Panel recommendations for the East Ballroom Lobby mentor artist, Alice Aycock, and two alternates Agnes Denes and Kristina Lucas with a vote of Ayes: 5, Noes: 0, and Absent: 4.

On June 29, 1994 at a special meeting the APP Committee approved the mentor artist's selection of Maru Hoeber and John Tucker for apprentices on the East Ballroom Lobby, with a vote of 4 ayes, 0 noes and 5 absent.

BACKGROUND:

The East Ballroom Lobby mentor/apprentice commission is a new direction for the Art in Public Places Program and it is one which is being watched nationally. The difficulty of making the transition from the studio to Public Art artists has been an ongoing weak link in Sacramento County. Reintroducing the tradition of mentor/apprentice to this commission is an effort bring new experiences to our local artists' community which we hope will translate into new opportunities.

Both the mentor and the apprentices will be required to formally summarize their experience in the final stage of the commission as part of the contract agreement. In addition, the apprentice artists will be expected to provide a workshop for local artists to teach the skills derived from this commission.

FINANCIAL CONSIDERATIONS:

The Public Art budget for the Convention Center Expansion Project is \$960,000, with funding derived from the 2% allocation of the construction budget. The East Ballroom Lobby budget is \$300,000, with \$275,00 allocated to the mentor artist for a large scale artwork and \$10,000 each for two local artist apprentices. A set aside budget of \$5,000 will provide the apprentices with a visit to the mentor's studio during the design and model building phase of the project.

SUMMARY:

Grants are being offered on a competitive basis, to organizations who *start or expand* arts programs in underserved areas. The applicant must establish both the lack of arts activities in the targeted neighborhood, and the need for the particular program being proposed. The grant period for the Enhancement Grant is the same as the Cultural Arts Awards: January to December, 1995.

BACKGROUND INFORMATION:

The Awards Committee has identified a lack of arts programs in the County unincorporated areas, portions of the City, and Folsom/Isleton/Galt (FIG). The purpose of this enhancement grant is to improve arts services throughout the community, particularly to neighborhoods which do not currently have extensive arts activities.

ACTION ITEM F

FINANCIAL CONSIDERATIONS:

The application for this grant will be considered concurrently with the Cultural Arts Award Grant, but will be funded separately, up to \$2,500 per applicant. Only one enhancement grant will be awarded per organization, which *must first be funded under the Cultural Arts Awards Program*. The Awards Committee will determine the recipients of all Enhancement Grants at the same time they allocate the Cultural Arts Awards funds. Up to \$25,000 (ten grants of \$2,500) which is .05% of the Regranting funds, may be used for this purpose.

POLICY CONSIDERATIONS:



The Awards Committee has identified a lack of arts programs in the County unincorporated areas, portions of the City, and Folsom/Isleton/Galt (FIG). The purpose of this enhancement grant is to improve arts services throughout the community, particularly to neighborhoods which do not currently have extensive arts activities. The goal is to reach new audiences, meaning those that have traditionally been underserved by the arts in general, and your program in particular.

Grants are being offered on a competitive basis, to organizations who *start or expand* arts programs in underserved areas. The applicant must establish both the lack of arts activities in the targeted neighborhood, and the need for the particular program being proposed. The applicant must make it very clear that this program is either completely NEW for your organization, or an EXPANSION of your existing program into a new geographic neighborhood that is underserved by the arts. Refer to the attached map.

The application for this grant will be considered concurrently with the Cultural Arts Award Grant, but will be funded separately, up to \$2,500 per applicant. Only one enhancement grant will be awarded per organization, which *must first be funded under the Cultural Arts Awards Program*. The Awards Committee will determine the recipients of all Enhancement Grants at the same time they allocate the Cultural Arts Awards funds. The grant period for the Enhancement Grant is the same as the Cultural Arts Awards: January to December, 1995.

MISSION STATEMENT

The purpose of the Visual Arts Committee is to serve as advocate for individual visual artists (defined as someone working in any variety of media pertaining to the disciplines of painting, sculpture, ceramics, fiber, mixed media, printmaking, photography, video and film making).

The Visual Arts Committee is, in addition, an advisory body to the Sacramento Metropolitan Arts Commission.

The Committee is currently focusing on outreach to artists and the wider community.

Goals for 1994-1995

- 1. Completion of a brochure explaining the Artists' Live/Work Space Ordinance.
- 2. Implementation of the Artists' Live/Work Space programs.
- 3. In an effort to begin outreach the Committee is exploring the publication of an Artists' Newsletter which would contain information helpful to the arts community served by the Sacramento Metropolitan Arts Commission. This newspaper could contain topics such as Calls for Entries, Grant Prospects, Artists' Live/Work Space and Local Art News and Happenings. The format would be fairly casual as would distribution.

4. Plan and host an Open Exhibition and Reception for Sacramento's visual artists. Scheduled for March 1995. Promotion of this event will be done by the Newsletter and other media as part of the publicity campaign.

5. Early in 1995, host an informational party for all interested artists in the area - the purpose of this event will be to let artists know about the Commission, the Committee, the Live/Work Space Ordinance, access to the media and other resources and opportunities for visual artists.

DIRECTOR'S REPORT/PROGRAM UPDATE JUNE 1994

ADMINISTRATION

City Council approved its 1994-1995 budget, which provides the same level of support for Metro Arts as the 1993-1994 budget. Staff is helping in the coordination of two summer murals initiated by La Familia. The murals are in the Meadowview and North Sacramento neighborhoods. The new Agency brochure will be completed in July and will be used as a marketing tool for additional funding and Friends of the Arts Commission's membership drive. Director Michelle Walker attended the Multicultural Tourism Conference in Los Angeles. The conference brought travel professionals from across the country together to discuss utilizing the arts and culture to promote tourism domestically and internationally (similar to what Italy, France and Great Britain have done so well).

APP PROGRAM

APP staff gave a slide presentation on June 28 to 70 teachers attending the Summer Art Institute hosted by the Crocker Art Museum. On June 30, the teachers chose from among three different tours of APP artwork--Downtown walking tour, carpool tour to outlying areas, and a sample school field trip tour. This year, staff, and intern Lane Aldridge, have supplemented teacher packets with new and detailed information to assist the regional teachers in sharing the APP Public Art collection with the children. Arts Program Assistant Kathy Gee developed the "Take A Hike" APP walking tour brochure-currently featured in the City Hall display cases.

On June 20 and 21, Alice Aycock, the mentor artist recommended for the Convention Center Expansion Project East Ballroom Lobby, was in Sacramento for a site visit. She was introduced to the Convention Center team of participants, and given detailed materials to support her project proposal. On June 21, Aycock, Nancy Esajian and Richard Raisler, the APP designate, interviewed seven apprentice applicants. Aycock recommended two local apprentices, Maru Hoeber and John Tucker, to work with her through installation of the artwork. The target date for the installation of the artwork is March 15, 1995.

REGRANTING PROGRAMS

Two workshops were held on June 11, the morning workshop was on Outreach & Education and the afternoon workshop on Board Development. A total of 60 representatives attended from a wide variety of arts and community organizations. Applications for the Cultural Arts Awards are due Monday, July 11. The Panel Orientation is scheduled for July 29, and the Panel will convene on August 25. Enhancement Grant applications will be available after the July Commission meeting. Meetings with elected officials continue to identify potential DAAC members. Follow

up meetings with CBOs will begin in July. Staff is working with the Arts Education Program on the "YA-YA" concept as a potential mentorship program. (A short video segment will be shown at the Commission meeting.)

ARTS EDUCATION

The Late Night Sacramento Program has added a new county site at the North Highlands Recreation Center. A twelve-week program in mural/graphic arts and drama/modeling has begun. The Rap Opera Visual Arts component is about to begin the 1994 Signature Square for the NAMES project. Planning with the Neighborhood Arts program continues for future programs. A Summer Youth employee, Marilyn Montenegro, will be assisting the Arts Education and Outreach Program for the summer.

CALIFORNIA COUNTRYSIDE FESTIVAL

The first Steering Committee Meeting for the Sacramento Fringe Arts Festival will be held on July 11. A focus group will be conducted on August 1. The festival will present a variety of disciplines in several locations along the K Street Mall. Targeting both Generation X and the Beat Generation, staff will seek their input and participation as focus group members.

FRIENDS OF THE ARTS COMMISSION

Kitty Simpson will be stepping down as President of Friends. Ms. Simpson will remain a Board member. Please join staff in thanking Kitty for her dedication, vision and hard work. As you know, Ms. Simpson was responsible for the creation and development of the Cultural Resource Directory. The Directory has become a tool to hire artists regionally and has been commented on favorably by our funders, the public and many elected officials. Ms. Simpson has been and is a strong supporter and advocate of the arts and the Arts Commission. Because of her support and enthusiasm, Friends has transitioned into a more proactive role as a supporter and catalyst for Commission programs. Please express your gratitude to Kitty for a job well done!





The Awards Committee has identified a lack of arts programs in the County unincorporated areas and portions of the City. The purpose of this enhancement grant is to improve arts services throughout the community, particularly to neighborhoods which do not currently have extensive arts activities. The goal is to reach new audiences, meaning those that have traditionally been underserved by the arts in general, and your program in particular.

Enhancement Grants will be offered on a competitive basis, to organizations who *start or expand* arts programs into underserved areas. The applicant must establish both the lack of arts activities in the targeted neighborhood, and the need for the particular program being proposed. The applicant must make it very clear that this program is either completely NEW for your organization, or an EXPANSION of your existing program into a new geographic neighborhood that is underserved by the arts. Refer to the attached map.

Up to ten Enhancement Grants will be awarded to organizations which are *first funded* under the Cultural Arts Awards Program. Maximum grant amounts are \$2,500, and only one may be awarded per organization. The applications for this grant will be reviewed and evaluated by the Awards Committee after they make their Cultural Arts Awards recommendations. The grant period for the Enhancement Grant is the same as the Cultural Arts Awards: January to December, 1995.

Thoroughness of Planning: The application will be evaluated on implementation plans, including well articulated goals, realistic timeline and budget, collaboration with community based organizations, and evaluation procedures.

Impact on Neighborhood: The application will be evaluated on the extent of need in the targeted community and how effectively the proposed program meets those needs.

Consistency with Program Goals: The application will be evaluated on how well the proposal meets the goals of the Neighborhood Enhancement Program to expand existing or create new programs in underserved geographic areas.
