SUBJECT: City of Sacramento's 1982/83 Community Development
Block Grant Application

SUMMARY

This report regards the City of Sacramento's 1982/83 Community Development Block Grant (CDBG) Application. The staff recommends the City Council adopt the attached resolution authorizing the City Manager to file the documents with the Department of Housing and Urban Development.

BACKGROUND INFORMATION

On January 19, 1982, the City Council approved the City's 1982/83 CDBG Activities Program, and ratified the related environmental document. The Council also authorized the City Manager to translate the program into required HUD forms for submittal to DHUD.

FINANCIAL DATA

On February 3, 1982, the City received correspondence from HUD indicating the City of Sacramento's firm target figures for fiscal year 1982/83 is \$4,244,000. This figure is less than the preliminary amount of \$4,500,000. Therefore, in order to reflect the latest figure, staff postponed two Capital Improvements Projects (South Avenue A/D (P/S) and Del Paso Heights A/D #8) for a savings of \$110,000, and reduced the 1982/83 CDBG Contingency Fund by \$146,000. The City Council was informed of this action on February 12, 1982.

RECOMMENDATION



RESOLUTION AUTHORIZING FILING OF APPLICATION FOR HOUSING AND COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS AND DESIGNATING THE CITY MANAGER AS CITY REPRESENTATIVE

WHEREAS, the City of Sacramento is entitled to Housing and Community Development Block Grant funds pursuant to the provisions of Title 1 of the Housing and Community Development Act of 1974; and

That the City Manager of the City of Sacramento is hereby designated as the authorized representative of the City to act in connection with the Application, and to provide all understandings and assurances required to be contained in the Application, and to furnish such additional information as may be required.
