BACKGROUND INFORMATION

A request has been received from the Farmers Free Market, owners of the entire block to abandon the Alley in the Block bounded by R, S & 30th Streets and Alhambra Blvd. This abandonment is being requested in order to better develop the Block. The various utility companies have no objection to the abandonment. The City Planning Commission has reviewed the proposed abandonment and has found it consistent with the 1977 General Plan and the 1966 Old City Community Plan for the area, thereby approving said abandonment:

WHEREAS, in the opinion of the City Council of the City of Sacramento, the public interest and convenience require the abandon-ment of the following described public right of way as provided under the street vacation act of 1941, Streets and Highways Code of the State of California;

NOW, THEREFORE, BE IT RESOLVED That the City Council of the City of Sacramento hereby declares its intention to abandon and vacate the following described public right of way in the City of Sacramento described as follows:

All of the Alley in the Block bounded by R, S, and 30th Streets and Alhambra Blvd., according to the official plat of map thereof. RESERVING HOWEVER, the right of entry to repair, maintain and construct sewer, water and gas pipes, and aerial or underground power, telephone and other communication facilities now in said Alley, or which from time to time may be placed therein. All proceedings in connection with the aforesaid abandonment are to be taken subject to such reservations and exceptions.

BE IT FURTHER RESOLVED AND ORDERED that on the 4th day of June, 1980, at the hour of 7:30 o'clock P. M. in the Council Chambers of the City Council of the City of Sacramento, on I Street between 9th and 10th Streets in said City, be, and the same is hereby fixed as the time and place for the hearing on the proposed abandonment of said public right of way.

BE IT FURTHER RESOLVED that the City Clerk be directed to publish notice of hearing of the proposed abandonment of said public right of way in the Sacramento Union, a daily newspaper, as required by law, and that said notice be posted along the right of way to be abandoned in accordance with the provisions of the Street Vacation Act of 1941, Sections 8300 to 8324, Streets and Highways Code of the State of California.
