SUBJECT: Agreement Between Pacific Gas and Electric Company and the City of Sacramento Allowing Construction and Maintenance of a Drainage Canal (Morrison Creek), C.C. 8599

SUMMARY

Attached for Council approval are copies of an agreement between the Pacific Gas and Electric Company and the City of Sacramento. The agreement will allow joint use of an area within an existing P.G.&E. power transmission line easement at the crossing location of realigned Morrison Creek.

BACKGROUND

In the course of widening and deepening the channel of Morrison Creek east of Florin-Perkins Road, as part of the Morrison Creek Assessment District, the alignment of the channel will be altered. The attached agreement allows the City and P.G.&E. common use of the area outlined by the intersection of the 75-foot wide P.G.&E. transmission line easement and the 150-foot wide right of way for the realigned channel.

FINANCIAL

There is no cost to the City directly related to this agreement. All cost of constructing the realigned channel of Morrison Creek will be borne by the property owners within the Morrison Creek Assessment District.
