AN ORDINANCE AMENDING SECTION 23.902 OF THE SACRAMENTO CITY CODE RELATING TO EXPANSION OF THE STOCKTON BOULEVARD BUSINESS IMPROVEMENT AREA

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

Section 23.902 of the Sacramento City Code is hereby amended to read as follows:

§ 23.902 Area Established - Description.

There is hereby established a business improvement area which shall be known as the "Stockton Boulevard Business Improvement Area of the City of Sacramento," herein referred to as the "Area" for brevity and convenience. The description of the Area is as follows:

Beginning at the intersection of Stockton Boulevard and X Street proceeding east to the northeast corner of County Assessor Parcel Number 011-0182-003-0000 then proceeding in a southerly direction on the east property line of the commercially zoned property fronting or adjacent to property fronting Stockton Boulevard to southeast corner of County Assessor Parcel Number 040-0032-018-0000 then west along the City limits line to the center of Stockton Boulevard then south to the southeast corner of County Assessor Parcel Number 039-0201-005-0000 then west along the City limits line to the southwest corner of County Assessor Parcel Number 039-0201-005-0000 then proceeding in a northwesterly direction on the west property line of the commercially zoned property fronting or adjacent to property fronting Stockton Boulevard excepting property not in the City limits to the northwest corner of County Assessor Parcel Number 014-0064-006-0000 then in a northeasterly direction along the boundary between County Assessor Parcel Number 014-0064-006-

0000 and County Assessor Parcel Number 014-0064-017-0000 to the center of Stockton Boulevard, then in a northwesterly direction along the center of Stockton Boulevard to the beginning.

The businesses located in the Area shall be subject to any future amendments to the "Parking and Business Improvement Area Law of 1989" (commencing with Section 36500 of the Streets and Highways Code). (Ord. No. 87-100, §1)
