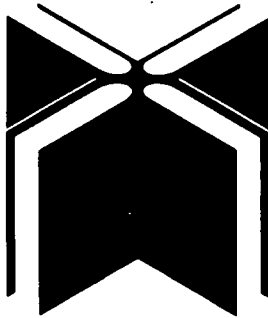

SUMMARY

The Library Director requests approval by the City Council of the execution of an employment agreement between the City of Sacramento, acting on behalf of the Mountain-Valley Library System, and James Allensworth, Mary Bass, Richard Hendricks, Tara Lavigne, Gerald Maginnity, Anna Murch, and Lillian Saulsberry. City Council action is required to make these agreements binding. Terms and conditions of employment covered by these agreements were approved by the Mountain-Valley Library System Administrative Council at its meeting on November 15, 1990.

BACKGROUND

The Mountain-Valley Library System is a consortium of independent city, county, college, university, and special libraries who have joined to form a cooperative network, providing interlibrary loans, reference backup, and delivery service for a nine county area in the the State of California.

FINANCIAL DATA

The City of Sacramento, as fiscal agent for the Mountain-Valley Library System, administers funds received pursuant to standard agreements between the State Department of Education, the State Library, and the City of Sacramento. There is no obligation on the part of the City of Sacramento to continue personnel employed with project funds after these funds have been expended.

Employment agreements reflect step increases for James Allensworth, Anna Murch, and Lillian Saulsberry to take effect December 1, 1990. Agreements also reflect cost of living raises for James Allensworth, Mary Bass, Richard Hendricks, Tara Lavigne, Gerald Maginnity, Anna Murch, and Lillian Saulsberry to take effect January 1, 1991.

POLICY CONSIDERATIONS

Consistent with past practice. City acts only as Fiscal Agent for Mountain-Valley Library System.

MBE/WBE EFFORTS

Not applicable to this item.


RECOMMENDATION

It is therefore recommended that the City Council Approve the attached Resolution authorizing the execution of employment agreements between the City of Sacramento and James Allensworth, Mary Bass, Richard Hendricks, Tara Lavigne, Gerald Maginnity, Anna Murch, And Lillian Saulsberry.

RESOLUTION AUTHORIZING THE EXECUTION OF EMPLOYMENT AGREEMENTS BETWEEN THE CITY OF SACRAMENTO AND JAMES ALLENSWORTH, MARY BASS, RICHARD HENDRICKS, TARA LAVIGNE, GERALD MAGINNITY, ANNA MURCH, AND LILLIAN SAULSBERRY FOR THE PROVISION OF SERVICES TO THE MOUNTAIN-VALLEY LIBRARY SYSTEM.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the City Manager is hereby authorized to execute employment agreements between the City of Sacramento and James Allensworth, Mary Bass, Richard Hendricks, Tara Lavigne, Gerald Maginnity, Anna Murch, and Lillian Saulsberry for the provision of services to the Mountain-Valley Library System.

1. Step increase of 5% for James Allensworth, Anna Murch, and Lillian Saulsberry effective December 1, 1990.
2. Cost of living increase for James Allensworth, Anna Murch, Lillian Saulsberry, Mary Bass, Richard Hendricks, Tara Lavigne, and Gerald Maginnity effective January 1, 1991. Employment agreements reflect final salary of all individuals as of January 1, 1991.
