# SUMMARY:

The City Engineer's office has prepared plans and specifications for the subject project and approval is recommended.

## BACKGROUND:

In October of 1979 the City Engineer's office received notification of complaints by residents that drainage in this area was inadequate. The complaint was investigated and solutions recommended. City forces corrected a few problem areas and the City Engineer's office prepared plans and specifications for this project. This project should alleviate any further problems within this area.

## FINANCIAL:

The project estimate is \$22,350. Since this project is not budgeted, the City Engineer proposes to use Miscellaneous Drainage Bond money to fund the project.

Approved in the 1979/80 City Engineer's Budget was \$100,000 for miscellaneous drainage projects. There remains \$60,500 of unused funds in this allocation. On July 1, 1980, however, this money reverts into the unappropriated fund balance. The City Engineer proposes to appropriate funds from the unappropriated fund balance after bids are received.

### RECOMMENDATION:

Staff recommends that the Budget and Finance Committee recommend to the full City Council that plans and specifications be approved and this project be advertised for bids.
