The meeting was called to order at the hour of 2:10 p.m. by Law and Legislation Committee Chairman Terry Kastanis, and roll was answered as follows:

1. Resolution declaring support for the concept of a Sacramento County Flood Control District.

MINUTES:

Mel Johnson, Director of Public Works, was present to discuss this matter. Also present was Gladys Iketa, of Senator Garamendi's office. Ms. Iketa assured Council members that they (Garamendi's office) will be working closely with City staff on this.

Councilman Kastanis suggested that the resolution be amended to add language stating that the committee working on this matter (SB 1604) consist of three elected officials from the City of Sacramento, three elected officials from the County of Sacramento, and one elected official from the City of Folsom (3-3-1), as originally suggested by Garamendi. There was a great deal of discussion regarding whether or not to include the words "elected official or his designee", and it was decided that having only elected officials was the best route to take at this time, and that since this is only the beginning, it could be amended later if desired.

There was some discussion regarding the resolution itself, and whether Mel Johnson was satisfied with it as it now reads. Mr. Johnson said that he was satisfied with the resolution, and that his department was instrumental in putting it together.

Jim Jackson asked if the Council members wished to add a paragraph instructing City staff to meet with Garamendi's staff to talk about additional provisions of this resolution.

A motion was made by Councilman Bradley to support the resolution declaring support for the concept of a Sacramento County Flood Control District, with an amendment adding the statement that the committee would consist of equal representation of three elected officials from the City of Sacramento, three elected officials from the County of Sacramento, and one elected official from the City of Folsom, as well as an amendment adding the statement that City staff meet with Garamendi's staff to discuss additional provisions of this resolution. Council member Robie seconded the motion, and it was carried as noted above.

2. AB 815 (Areias) relating to parking of large trucks in residential areas.


MINUTES:
