The Personnel Committee has interviewed candidates for this Board and is prepared to make a recommendation to you for this important appointment.

We have been blessed and cursed in that the candidate field was absolutely the best we've ever experienced. Without exceptions, the applicants were very well qualified for appointment. That's a blessing. The curse is trying to choose one.

Councilman Thompson came up with a brillant solution: expanding the Board. Since the composition of the boards is fixed in the Charter, this is not an immediate solution to our problem, though the Council might well want to consider this in the future.

The Committee has agreed to recommend the appointment of Yvonne M. L. Mulder, whose resume is attached. Ms. Mulder is an Account Executive at Dean Witter Reynolds. She is experienced in the areas of the Board's responsibilities, recognizes that maximum return investment is the principal objective of the Board but is sensitive to the need and potential for investments that might provide an equal return and benefit Sacramento as well, and is an articulate and forceful participant.
