The annual re-evaluation of the Natomas Basin Habitat Conservation Plan (NBHCP) Finance Model is required by Sections 3.2.6 and 4.9.2 of the Implementation Agreement, and is performed by the City's NBHCP Plan Operator - The Natomas Basin Conservancy (TNBC). On December 7, 2016, TNBC's Board of Directors recommended that the fee amount be decreased to reflect the fee amount indicated by the 2017 NBHCP Finance Model recalculation. Staff is proposing a Resolution adjusting the amount of the Natomas Basin Habitat Conservation Plan (HCP) fee, to be effective in 60 days.
