SUBJECT: Suspension of Formal Competitive Bidding for the Procurement of Annual Maintenance Services for the Community Center's Honeywell Delta 2000 Automation Control System

SUMMARY

The Community Center has a continuing need for a maintenance contract for their Honeywell Delta 2000 Automation Control System. Since these services are only available from Honeywell Incorporated, the manufacturer, it is recommended that the City Council suspend formal competitive bidding for this requirement.

BACKGROUND INFORMATION

These controls were installed as an integral part of the Community Center's climatic control system during the construction of the Community Center. Honeywell Incorporated has been performing work on these controls under a preventive maintenance contract since the system was initially installed. The preventive maintenance program includes routine inspections and repairs to the system, all emergency calls and replacement of any defective or malfunctioning components within the system.

FINANCIAL DATA

The annual cost for these services is \$16,264. Sufficient funds have been approved in the Community Center's 1980/81 fiscal year budget.

RECOMMENDATION

It is recommended that the City Council adopt a resolution suspending formal competitive bidding for the procurement of annual maintenance services



RESOLUTION SUSPENDING FORMAL COMPETITIVE BIDDING FOR THE PROCUREMENT OF ANNUAL MAINTENANCE SERVICES FOR THE COMMUNITY CENTER'S HONEYWELL DELTA 2000 AUTOMATION CONTROL SYSTEM AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE NECESSARY CONTRACT
