SUBJECT: Rescinding the Award for Air, Gas, Oil and Water Filters, Bid No. 831,

SUMMARY

The Fleet Management Division has a requirement for air, gas, oil and water filters for City vehicles.

BACKGROUND INFORMATION

Formal bids (Bid No. 831) were solicited from specifications adopted by City Council on May 28, 1985. Six bids were received from fifteen solicitations. The City Council awarded the contract to Specialty Filter Corporation on July 16, 1985 based on staff's recommendation. The City attorney has since advised staff that its evaluation was invalid.

FINANCIAL DATA

Sufficient funding is available in the FY 85/86 budget for these items.

RECOMMENDATION

It is recommended that the City Council rescind its award of this contract to Specialty Filter Corporation and readvertise for bids with an opening date of September 17, 1985.
