

My name is Richard Johnson; I am the owner and operator of The Alternator Shop. Certified by the State and City as a Small Business, I am one of over a hundred vendors now doing business with the Sacramento City Fleet Service.

You are being asked to approve a twenty one million dollar, five year, no bid contract with NAPA Auto Parts to take over the City's Fleet Maintenance Parts Department. You are being told that it is going to save the city an average of 394,000 dollars a year. This is not true. As I proved with actual city invoices in a package that, I delivered to each of you the 3rd week in October. With NAPA, the cost of parts will be much higher than what you are now paying with the competitive bid process now in place by 30-39%.

Of course, Fleet Management knows this, and the reason they are presenting this change is not to save the city money, but to get the city purchasing and billing responsibilities away from the Fleet Management (which has been a problem for them for years) and let NAPA handle it!

By offering NAPA as a solution, Fleet Management is admitting that the problem is out of control and that they do not know how to fix it. But, regardless of the added cost and the fact that they will be outsourcing the jobs of over a hundred Sacramento vendors and twenty-one million tax dollars, they will have solved their problem by outsourcing the Fleets accounting department and handing NAPA an open check book to set their own prices. Who is going to check the thousands of invoices each year? The State of California had the same type of contract for office supplies with The Office Depot. We all saw how that worked out!

Bringing NAPA into the City Fleet Service Parts Program as the sole supplier will have the same effect on the Sacramento business community as Walmart moving into a small town. Just like Walmart, NAPA will outsource over twenty-one million tax dollars out of the city and the state's economy with a good portion of it going to Mexico and China. Tax dollars that now mostly stays here in Sacramento. In today economy, this is not a popular move.

Before any decisions are made; please take the time to bring in some of the Fleet Department Staff and talk privately to the people doing the job and let them tell you what the problems and answers are.

Napa is not the answer.

Successful bidder shall stock an adequate supply of exchange alternators
