SUBJECT: Joint Use and Development Agreement with the Sacramento City Unified School District

SUMMARY

This report recommends that the City Manager, by resolution, be authorized to execute an agreement between the City and Sacramento City Unified School District for the use and development of certain school and City facilities for community recreation purposes.

BACKGROUND INFORMATION

The City and the Sacramento City Unified School District have a long history of cooperation in providing meaningful recreational experiences to citizens of the City and School District and in the joint development of facilities. This cooperation and joint development have been formalized through various joint use agreements, specific agreements for individual site development and in the summer of 1981 a co-sponsorship agreement for summer programs and activities.

This agreement is designed as a blanket open-ended document covering the basics of joint use and development including fee-exempt usage of each agency's facilities by the other and provisions for continued joint development of facilities. It is anticipated that specific program proposals and/or specific site improvements will be covered by separate agreement or addendum to this main agreement.

FINANCIAL DATA

There is no financial commitment on the part of the City for use of facilities and only the appropriated costs for each site park development as approved at some later date by the City Council.
