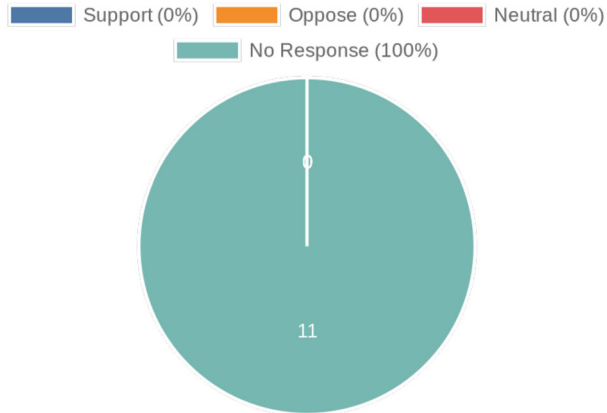

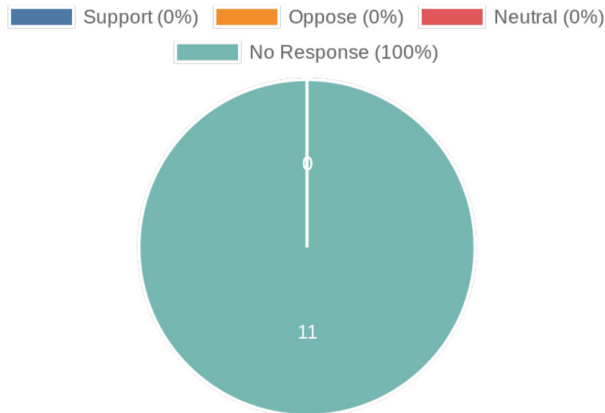

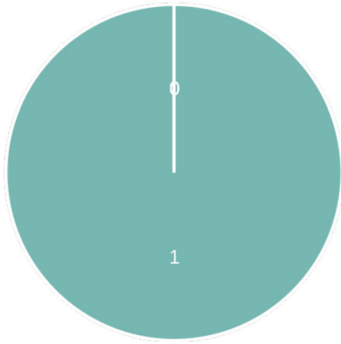
Overall Sentiment
