**SUBJECT: ADOPTION OF SPECIFICATIONS AND AWARD OF BID NO. 1777 FOR ASPHALT AND AGGREGATE MATERIALS IN A TOTAL AMOUNT NOT TO EXCEED \$900,000.00 PER CONTRACT YEAR**

**LOCATION AND COUNCIL DISTRICT:** City-wide; All districts

**RECOMMENDATION:**

Staff recommends that the City Council adopt specifications and accept the lowest responsible bids for the contracts resulting from Bid No. 1777 for Asphalt and Aggregate Materials. Award is recommended to Teichert Aggregates and Granite Construction in a total amount not to exceed \$900,000.00 per contract year.

**SUMMARY:**

Attached is a tabulation of sealed proposals received by the City Clerk for furnishing material in accordance with the specifications used in the bidding process, and recommendation for award of Bid No.1777 for Asphalt and Aggregate Materials.

**BACKGROUND:**

This contract for asphalt and aggregate materials for street and road repairs will be used primarily by the Street Division of the Department of Public Works. Various divisions within the Utilities Department also purchase material off this contract.

Staff recommends that contracts be awarded to both Teichert Aggregates, 3500 American River Drive, Sacramento, CA 95864, and Granite Construction, 3801 Power Inn Road, Sacramento, CA 95826, in a total amount not to exceed \$900,000.00 per contract year. Theirs were the two lowest responsive bids received as shown in the attached bid tabulation sheet. Teichert Aggregates' plant is closest to the City Corporation Center-South. When City transportation costs are factored, Teichert Aggregates becomes the lowest overall bidder, and as such, will be the City's primary source. Granite Construction will be used as a secondary or back-up source. Because the bid totals represent those items selected for bid evaluation purposes only, staff recommends that the City Council authorize contracts in a total amount not to exceed \$900,000.00 per year, which more closely reflects the actual amount anticipated to be expended each year of this potential five year contract.

**FINANCIAL CONSIDERATIONS:**

Sufficient funds have been budgeted by both the Department of Public Works and Utilities Department for FY98/99 under Object Code 4472 for Asphalt and Quarry.

**ENVIRONMENTAL CONSIDERATIONS:**

Ongoing administrative and maintenance activities, such as purchases of supplies, equipment or materials which are not made for purposes of a public works construction project, do not constitute a "project" and are exempt from the California Environmental Quality Act (CEQA). CEQA Guidelines, Sections 15061(b)(1), 15378(b)(3).


**POLICY CONSIDERATIONS:**

This recommendation is consistent with the requirements for competitive bidding as detailed in Title 57 of the Sacramento City Code.

**MBE/WBE EFFORTS:**

There are no local M/WBE firms known or listed in the City Bid Directory that supply these construction materials. It is necessary to buy locally, as these materials are purchased F.O.B. vendor's plants and are picked up by various City departmental personnel in City trucks. Soliciting bids and/or purchasing these materials outside the general Sacramento area would not be economical or in the best interest of the City.
