SUMMARY

This report recommends a 5.5% salary increase to the Computer Services Manager exempt classification due to persistent recruitment difficulties.

BACKGROUND AND ANALYSIS

The Computer Services Manager class was established in October 1988 and previous to that, a similar class, Technical Systems Manager, was responsible for overseeing systems programming in the Data Management Department. The current Computer Services Manager class is responsible for supervising personnel in computer operations, as well as the professional and highly technical class of Systems Programmer. Because systems programming is so technical and highly specialized, recruitment is extremely difficult. While this difficulty is evident at all levels of systems programmers, it is especially acute at the manager level. The most recent attempt at recruitment for the manager position yielded only a handful of applicants with only a few qualifying for the oral board. No appointment was made since none of the final candidates met all the criteria needed for the position.

In order to help ease the recruitment difficulty for Computer Services Manager, a salary increase of 5.5% is proposed. This would raise the current salary from \$3,891.33 - \$4,729.92 to \$4,105.40 - \$4,990.09 per month. The new salary would line up with Supervising Engineer, a management class with a similar level of responsibility and technical expertise.

No changes are recommended for either the exempt status of the class or the current conflict of interest disclosure categories.

FINANCIAL IMPACT

The additional funding required to implement the 5.5% increase for the Computer Services Manager is available through a department-wide salary savings in the Data Management Department; therefore, there will be no financial impact.
