SUBJECT: Sacramento Boat Harbor Vending Machine Concession Contract

### SUMMARY

This report recommends the award of the Sacramento Boat Harbor Vending Machine Concession Contract to Nor-Cal Beverage Company, Inc. The contract is for three (3) years.

### BACKGROUND

The City Clerk received one (1) bid for the Concession contract.

### FINANCIAL DATA

The City receives a quarterly payment in an amount calculated according to a schedule of commissions for various items. This varied under the existing contract from \$35 to \$153 quarterly.

The financial considerations of the bid by Nor-Cal Beverage Company, Inc. are as follows:




