Honorable Members in Session:

SUBJECT: Amendment of Section 40.709 of the City Code

SUMMARY:

Submitted is an ordinance amending Section 40.709 of the City Code by changing the size of boundary monuments from 1-1/4" to 1" diameter iron pipe. It was brought to staff's attention that the 1" size is the more standard size and better facilitates the use of standard identification caps used by private surveyors. Therefore, it is recommended that this amendment be enacted.

FINANCIAL:

Adoption of this ordinance will have no financial impact on the City.

RECOMMENDATION:

It is recommended that Section 40.709 of the City Code be amended by changing the size of boundary monuments from 1-1/4" to 1" diameter iron pipes, by adoption of the attached ordinance.

AN ORDINANCE AMENDING SECTION 40.709 OF
THE CODE OF THE CITY OF SACRAMENTO

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO AS FOLLOWS:

SECTION 1

Section 40.709 is hereby amended as follows:

Sec. 40.709. Monument type and positioning.

Boundary monuments shall consist of ^{one inch (1")} ~~1 1/4~~ diameter iron pipes, 18" long. Temporary interior monuments for construction purposes shall consist of 2"x2"x8" long wood hubs with cup tacks. Permanent interior monuments shall consist of 1/4" diameter Parker-Kalon nails, 1-1/2" long. All monuments shall be set securely to ground level.
