SUBJECT: Ammending Through Street Resolution 82-517

SUMMARY AND BACKGROUND

For traffic safety, whenever the speed limit on a street is 30 MPH or greater, the intersecting streets are posted with stop signs making the street a through street. This resolution includes streets that the City Council will consider under the Speed Limit Resolution which is being presented concurrently with this resolution. This revision also includes the description of the limits of the through streets which conforms with the speed limit Resolution. The modifications to be considered in this ammendment are Front Street and Mack Road.
