SUBJECT: 1401 K Street - Authorization to Execute Lease and Cancel Prior Lease

SUMMARY

Adoption of the attached resolution approving a lease of office space at 1401 K Street to Futurtek Communications, Inc. on a basis of month to month tenancy and cancellation of the prior lease is recommended.

BACKGROUND

The office building at 1401 K Street was acquired by the City in July 1985. Space in this building, not used by the City, has generally been leased on a short-term or month to month tenancy basis.

Futurtek Communications, Inc., a telecommunication business with headquarters in San Francisco, is currently occupying 2,223 square feet in the building under a lease which expires September 30, 1988. They wish to retain the same space on a month to month basis for office space and storage of their equipment.

In July, 1988, Futurtek executed a lease for 375 square feet on a month to month basis for their telephone equipment and a small office. They were in the process of renting additional office space at another location. That lease did not materialize and they now wish to remain in their existing space on a month to month basis with a ninety day termination privilege by either lessor or lessee. The new lease, beginning October 1, 1988, will be a continuation of their original lease.

FINANCIAL

The lease provides for a monthly rental rate of two thousand, nine hundred eighty-one dollars and eighty-five cents (\$2,981.85) per month. Funds are to be deposited to the Community Center Fund. (419-430-4340-3670).

It is recommended that the City Manager and the City Clerk be authorized to execute the lease by adoption of the attached resolution.
