SUMMARY:

The Office of Emergency Services requests your approval of the City Signature Resolution for purposes of executing the Energy Shortage Response Plan under a grant from the California Energy Commission.

#### BACKGROUND:

On October 27, 1992, the Sacramento City Council authorized the City of Sacramento Office of Emergency Services to apply for a Local Government Contingency Planning Grant. (Resolution #92-775). In December, 1992 a grant was awarded in the amount of \$84,800. The purpose of the grant is to enhance the local jurisdiction's ability to manage the impacts of a disruption to the supply or distribution systems for petroleum, natural gas, and electricity. The award provides funding for developing a task force management system, communication, conservation and mitigation strategies, testing the plan, and training staff.

#### FINANCIAL CONSIDERATIONS:

This resolution has no direct financial impact.

#### **POLICY CONSIDERATIONS:**

The purpose of this resolution is procedural, i.e. to authorize the signatures of the Fire Chief and his two designees to execute the grant.
