Subject: Human Rights/Fair Housing Commission

SUMMARY

This report recommends that \$26,625 be appropriated from the General Fund Contingency to pay the Human Rights/Fair Housing Commission its 1981-82 fourth quarter payment.

BACKGROUND

The 1981-82 Budget appropriated \$106,500 in General Funds to the Human Rights/Fair Housing Commission. This money was to be allocated in four equal payments. The first three payments were made in a timely fashion. However, the fourth quarter payment was inadvertently missed.

The missed fourth quarter payment was recently brought to the City's attention by the Commission. In the meantime, the remainder of the 1981-82 Budget appropriation had been reverted to fund balance at the close of the last fiscal year. Therefore, it is necessary to appropriate \$26,625 for the delinquent fourth quarter payment from the General Fund Contingency in order that the City may fulfill its financial obligation to the Commission for 1981-82.

FINANCIAL

The General Fund Contingency has sufficient funds to provide for an appropriation of \$26,625.

RECOMMENDATION



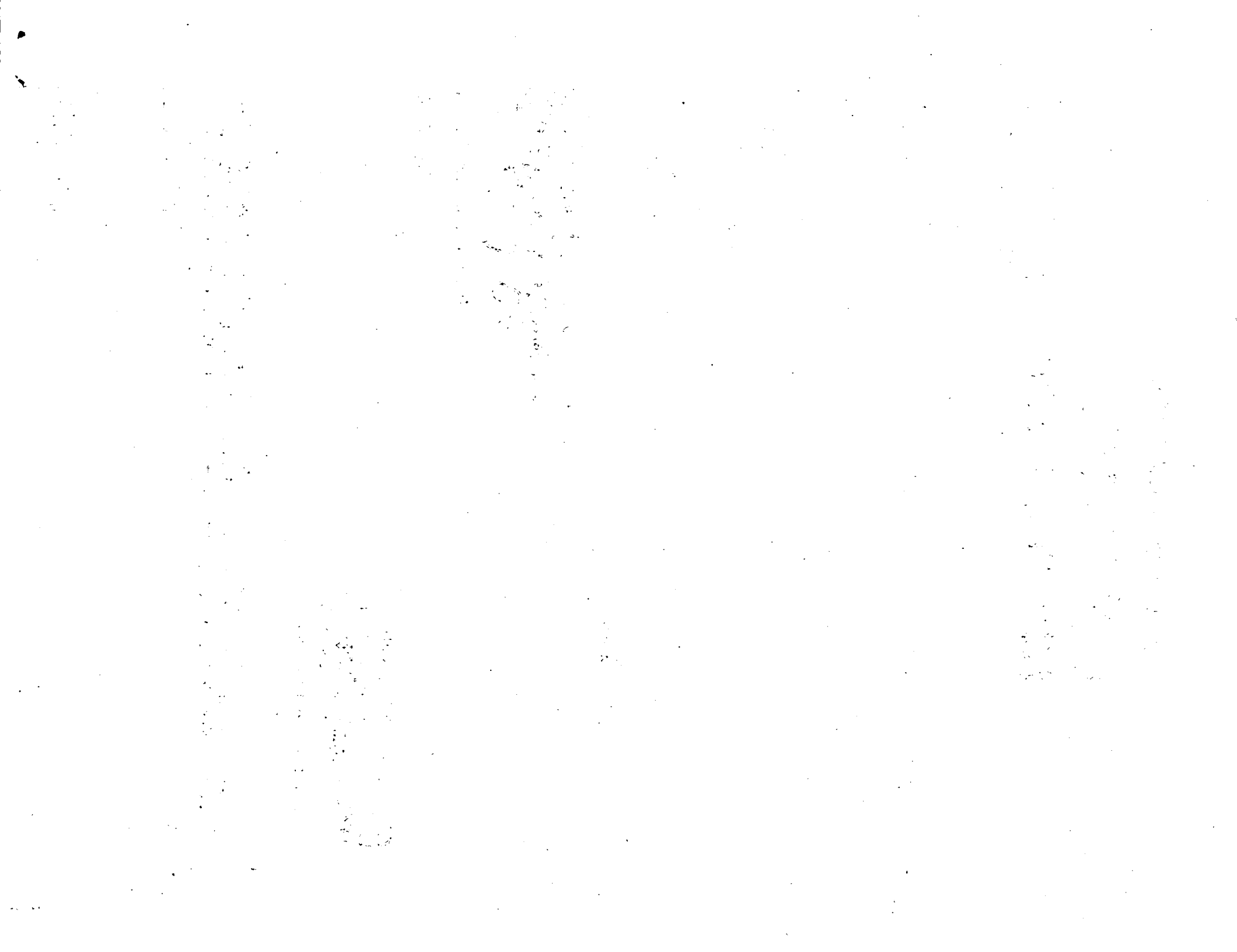

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

A RESOLUTION APPROPRIATING \$26,625 FROM THE
GENERAL FUND CONTINGENCY TO MAKE THE HUMAN RIGHTS/
FAIR HOUSING COMMISSION FOURTH QUARTER PAYMENT FOR 1981-82

WHEREAS, the 1981-82 Budget appropriated \$106,500 in General Funds to the Human Rights/Fair Housing Commission of which \$79,875 was spent in 1981-82 with the remaining \$26,625 reverting to fund balance at the end of the fiscal year, and
