SUBJECT: Construction of Sidewalk on 2nd Avenue West of 43rd Street,
Improvement Proceeding No. 5301

SUMMARY:

Adoption of a Resolution fixing the Hearing date for approval of the Superintendent of Street's Report on the cost of constructing a sidewalk on 2nd Avenue adjacent to 4224-2nd Avenue.

BACKGROUND:

The City Engineer received complaints that there was no sidewalk in front of the property at 4224-2nd Avenue. The property owner, Nora P. West, P. O. Box 161453, Sacramento, California, 95816 had no objection to the construction of the sidewalk but desired to have the construction cost placed as a lien on her property so that she could pay it off as part of her tax bill in two equal installments rather than one lump sum.

Attached is a Resolution fixing the Hearing date on the Superintendent's Report which states the cost of said sidewalk.

FINANCIAL:

The cost for the construction of the sidewalk adjacent to 4224-2nd Avenue was \$460.00 and this amount has been expended out of Street Maintenance Budget 1-01-2810-8019-4241. This amount will eventually be recovered when Mrs. West pays her City and County tax bill which will include this amount as a lien.

RECOMMENDATION:


It is recommended that the attached Resolution be adopted which sets a Hearing on the Report for June 14, 1983.

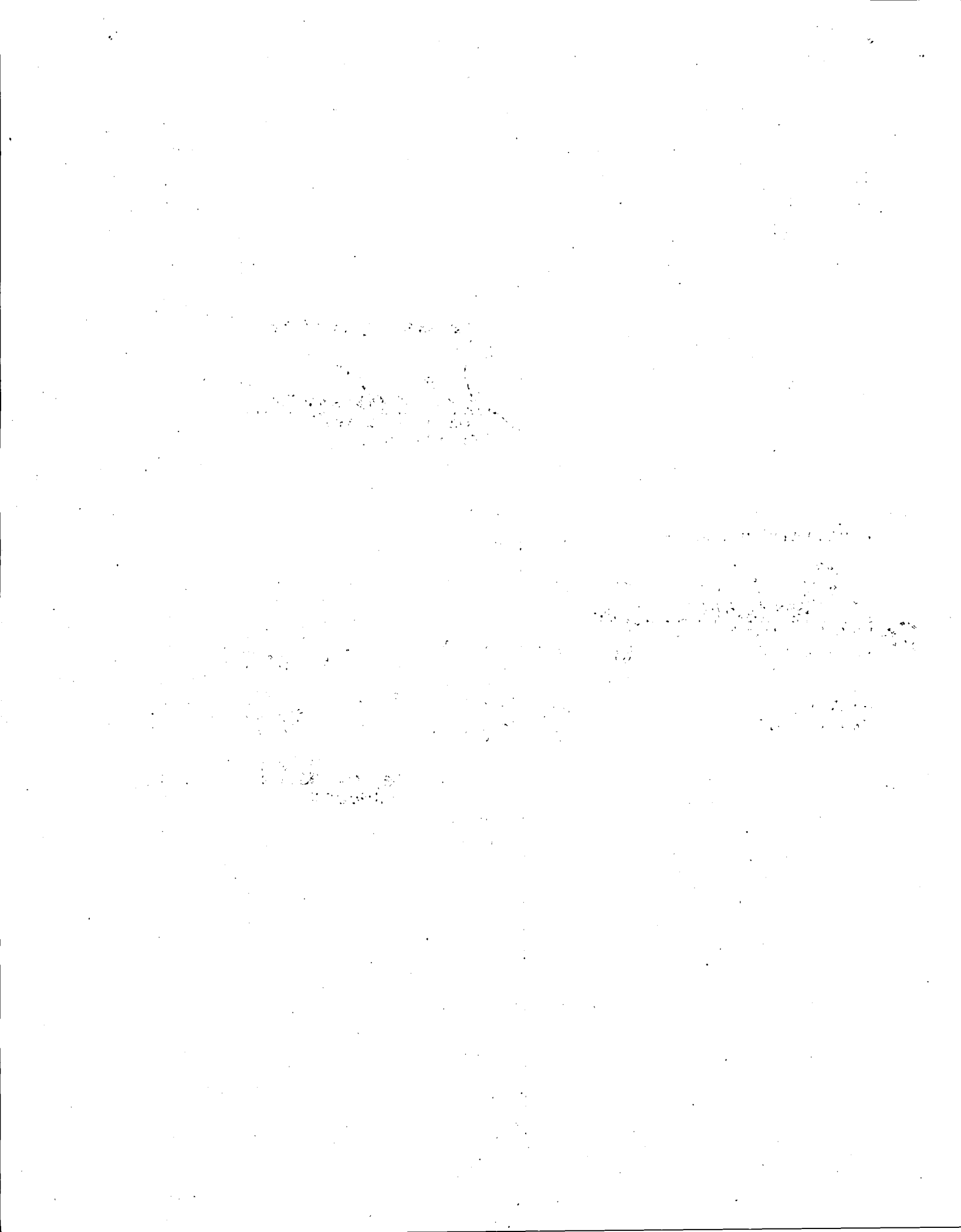

RESOLUTION FIXING THE DAY HOUR AND PLACE FOR THE HEARING AND PASSING UPON REPORT OF THE SUPERINTENDENT OF STREETS ON THE COST OF CONSTRUCTING SIDEWALK IN A PORTION OF 2ND AVENUE WEST OF 43RD STREET

Improvement Proceeding No. 5301

WHEREAS, the Superintendent of Streets has, under and pursuant to the provisions of Division 7, Part 3, Chapter 27, of the Streets and Highways Code (The Improvement Act of 1911), constructed a sidewalk in a portion of 2nd Avenue and 43rd Street, and

WHEREAS, the Superintendent of Streets did on May 24, 1983, file with City Council his report specifying the work which has been done, the cost of construction, a description of the real property in front of which the work has been done, and the amount of the assessment against each lot, piece or parcel of land proposed to be levied to pay the cost thereof;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That on June 14, 1983, at 7:30 o'clock P.M., in the Council Chambers of the City of Sacramento, City Hall, I Street between 9th and 10th Streets in said City, is hereby fixed as the day, time and place for the hearing and passing upon the above-mentioned reports, and any objections or protests which may be raised by any property owner liable to be assessed for the cost of such construction of such sidewalk, and any other interested person, and for the confirmation thereof.
