Title: A public hearing to consider (1) the California Public Finance Authority's issuance of revenue bonds to finance or refinance the acquisition and improvement of the Farmer's Market Complex within the City of Sacramento; and (2) the City Council's adoption of a resolution approving the issuance of the bonds

Location (of Project): District 3

On September 27, 2016, as required by Government Code section 6586.5, the Sacramento City Council will hold a public hearing on the proposed issuance by the California Public Finance Authority (the "Borrower") of revenue bonds in one or more series in an amount not to exceed \$86,690,000 (the "Bonds"). The proceeds of the Bonds will be used (1) to finance the acquisition and improvement of three multi-story office buildings at 1801 30th Street, 1820 Alhambra Blvd., and 1727 30th Street and one parking garage at 2910 S Street (collectively, the "Farmer's Market Complex"); and (2) to pay certain expenses incurred in connection with the issuance of the Bonds.

The Bonds will be an obligation of the Borrower alone, payable solely from certain revenues duly pledged therefor. The City of Sacramento will not be obligated to pay any principal of, interest on, redemption premium for, the Bonds or any fees or other costs associated with the Borrower's issuance of Bonds. The Bonds and the obligation to pay principal of, interest on, and redemption premium (if any) for, the Bonds will not constitute (1) indebtedness or an obligation of the Borrower, the City of Sacramento, the State of California, or any political subdivision of the State of California within the meaning of any constitutional or statutory debt limitation; or (2) a charge against the general credit or taxing powers of any of them.

The hearing will begin at 6:00 p.m. (or as soon thereafter as the matter can be heard) and will be held in the City Council Chambers, Sacramento City Hall, 915 I Street, 1st Floor, Sacramento, California. Interested persons wishing to express their views on the issuance of the Bonds or on the nature and location of the facilities proposed to be financed may attend the public hearing or submit written comments at any time before the hearing begins.
