SUMMARY

This report recommends approval of a contract for funding of arts activities between the City and the Sacramento Symphony Association.

BACKGROUND

In FY87/88, the City Council appropriated \$30,000 for the Sacramento Symphony as part of the City's regranting program for support to local cultural organizations. This regranting program is under the auspices of the Sacramento Metropolitan Arts Commission.

The Sacramento Metropolitan Arts Commission's operating budget in FY88/89 includes an allocation of \$30,000 for the third and final year of support for cultural programming to the Sacramento Symphony.

FINANCIAL DATA

Funding for the Sacramento Symphony at \$30,000 is included in the Sacramento Metropolitan Arts Commission's approved FY88/89 budget. No additional funds are required.
