### SUMMARY

Attached hereto is a petition signed by property owners representing more than 60% of the Area to be assessed for the construction of a Sanitary Sewer System Complete, together with all necessary appurtenances, in Amador Avenue Sanitary Sewer Assessment District; in the City of Sacramento.

The petition provides for a Waiver of the Special Assessment Investigation, Limitation and Majority Protest Act of 1931.

Approval of the petition by adoption of the attached Resolution provides that the City Council finds that the property owners have WAIVED the above mentioned Act.

On February 10th, 1981, Council adopted Resolution No. 81-086, approving a petition for the Amador Avenue Water Assessment District. It is now desirable to combine the two petitions under one improvement proceeding.

# FINANCIAL DATA

This project is to be paid for in its entirety by the property owners within the proposed assessment district.
