# LOCATION AND COUNCIL DISTRICT:

Old Sacramento - Council District 1. (See location map - Attachment A).

This report recommends that the City Council adopt the attached Resolution:

• Approving a construction contract with Harbison-Mahony-Higgins (HMH) Builders Inc. in the amount of \$223,022 (Fund 202).

#### **SUMMARY:**

The Old Sacramento ADA Upgrade Project (PN: RK31) is a result of a lawsuit involving the City of Sacramento and is related to accessibility to facilities in Old Sacramento. The "K" Pedestrian Tunnel Ramp improvements are one component of the Old Sacramento ADA Upgrade Project (PN: RK31), and will provide an accessible ramp from the tunnel to Old Sacramento. The alterations required to construct the ramp shall be substantially completed by September 30, 2003.

Entering into a construction contract with HMH will allow completion of the project within the mandate set by the Court, and prevent financial penalties that may be levied against the City if the mandate is not met.

# **BACKGROUND INFORMATION:**

The Old Sacramento ADA Upgrade Project (PN: RK31) includes multiple sub-projects and is a result of the lawsuit involving the City of Sacramento, and is related to Americans with Disabilities Act accessibility to facilities in Old Sacramento. All of the corrective work will be performed in compliance with the standards and specifications for disabled access as set forth in the California Code of Regulations, Title 24-2 and the Americans with Disabilities Act Accessibility Guidelines (ADAAG).

HMH was one of four construction companies chosen through a competitive qualifications based selection process. The City Council has authorized a Master Contract List with pre-qualified design build contractors to provide ADA modifications to various City projects. HMH was the next contractor in line when the Old Sacramento ADA project started. HMH has successfully completed-on-time-and-within-budget-the-first-group-of-parking-modifications-to-both-surface-parking and parking garages, and such modifications comply with the Court mandated ADA changes.

The "K" Street Pedestrian Tunnel Ramp improvements include modifications to the stairway adjacent to Parking Lot P and the K Street Pedestrian Tunnel as necessary to construct the accessible ramp from Parking Lot P and K Street Tunnel into Old Sacramento. The path of travel from the ramp into Old Sacramento will not exceed a 1:12 slope, will have level landings, and handrails as required by ADAAG and California Building Codes.

The Court has mandated the completion of the "K" Street Pedestrian Tunnel Ramp by September 30, 2003. HMH is prepared to start construction August 20, 2003, and be substantially complete with the project by September 30, 2003, which is sufficient to meet this mandate.

#### FINANCIAL CONSIDERATIONS:

The Old Sacramento ADA Upgrade Project (PN: RK31) has a current budget of \$2,175,000 and an unobligated balance of \$1,908,443, which is sufficient to execute the agreement in the amount of \$223,022 (Fund 202) with Harbison-Mahony-Higgins (HMH) Builders Inc.

The Planning and Building Department, Office of Environmental Affairs, has reviewed the project and has determined that this project is exempt from the California Environmental Quality Act (CEQA) under Section 15301 of the CEQA Guidelines. Section 15301 exempts minor alteration of existing public or private structures and facilities.

# **POLICY CONSIDERATIONS:**

The action requested herein is consistent with the Sacramento City Code, Title 3. This action is consistent with the City of Sacramento's Strategic Plan goal of promoting, enhancing and supporting economic vitality.

# **ESBD CONSIDERATIONS:**

Emerging and Small Business Development Enterprise participation on this project exceeds the minimum of the required 20%.


