SUBJECT: MODIFICATION OF THE STATE CAPITOL RESIDENTIAL PERMIT PARKING AREA BY ADDING THE EAST SIDE OF 15TH STREET BETWEEN N AND O STREETS

Summary

This report recommends the addition of the east side of 15th Street between N and O Streets to the State Capitol Residential Permit Parking Area.

Background

A petition, representing 91% of the residential units of the Biele Place apartment complex, has been submitted to add this street segment (east side of 15th Street between N and O Streets) to the State Capitol Residential Permit Parking Area. Based on the petition and survey data showing 100% curb occupancy, it is recommended that this street segment be added to the State Capitol Residential Permit Parking Area.

Financial Data

Funds are available in the existing 1984/85 Operating Budget to implement, operate and maintain this addition to the State Capitol Residential Permit Parking Area.

Recommendation

It is recommended that the attached resolution adding a portion of 15th Street to the State Capitol Residential Permit Parking Area be adopted.
