SUBJECT: Improvement Proceeding No. 5226, Main Avenue
Sanitary Sewer Assessment District

SUMMARY

Attached hereto is a petition signed by property owners representing more than 60% of the area to be assessed for the construction of a sanitary sewer system and pumping station, together with all necessary appurtenances for the above described improvements, in Main Avenue Sanitary Sewer Assessment District; in the City of Sacramento.

The petition provides for a Waiver of the Special Assessment Investigation, Limitation and Majority Protest Act of 1931.

Approval of the petition by adoption of the attached Resolution provides that the City Council finds that the property owners have WAIVED the above mentioned Act.

FINANCIAL DATA

This project is to be financed jointly by the property owners within the proposed district and the City of Sacramento. The City's portion is estimated to cost \$89,250.00 and is available in the Sewer Fund 414. The balance of the cost is to be assessed against the property owners.


RECOMMENDATION



RESOLUTION APPROVING PETITION

FOR IMPROVEMENT PROCEEDING NO. 5226

**MAIN AVENUE SANITARY SEWER
ASSESSMENT DISTRICT**

WHEREAS, a petition has been filed with the City Council requesting that proceedings be adopted for the improvement of

MAIN AVENUE SANITARY SEWER ASSESSMENT DISTRICT,

in the City of Sacramento; and

WHEREAS, the signers of said petition state that they are all of the Owners of more than 60% of the area liable for Assessment for said work and improvement, and they expressly "WAIVE" the provisions of Division 4 of the "Streets and Highways Code of the State of California" (The Special Assessment Investigation, Limitation and Majority Protest Act of 1931), as amended, and all investigations, proceedings and reports provided for therein; and

WHEREAS, the said petition has been checked by the City Engineer's Office and found that the WAIVER is signed by the Owners of more than 60% of the area liable for Assessment for said work.

NOW, THEREFORE, BE IT RESOLVED by the City Council that the said petition is hereby approved and granted; and

BE IT FURTHER RESOLVED that the City Council hereby finds and determines that the WAIVER in said petition is signed by the Owners of more than 60% of the area liable for said work and improvement and hereby directs that proceedings for said work be authorized as provided in Division 4 of the said Streets and Highways Code, THE IMPROVEMENT ACT OF 1911.
