SUMMARY

The Budget and Finance Committee recommends that the City Council adopt the attached resolution which establishes 7:30 p.m., July 26, 1988 in the City Planning Commission Hearing Room, 1231 I Street, Room 102 Sacramento, California, 95814 as the time, date, and place for hearing protests, if any, for weed abatement work performed in the spring of 1988.

BACKGROUND

City Council Resolution No. 86-764, adopted October 7, 1986, declares the City Council's intent for staff to bill semiannually for weed abatement work performed. The resolution also states that the City Council will conduct a lien hearing for the unpaid billings approximately thirty days after the bills are mailed.

DISCUSSION

Bills for weed abatement work performed in the spring of 1988 were mailed June 21, 1988. The total number of accounts billed this year as compared to last year increased by 143, which represents an increase of 12.9%.

RECOMMENDATION

The Budget and Finance Committee recommends that the City Council adopt the attached resolution which establishes 7:30 p.m., July 26, 1988 in the City Planning Commission Hearing Room, 1231 I Street, Room 102, Sacramento, California, 95814, as the time, date, and place for hearing protests, if any, for weed abatement work performed in the spring of 1988.


