# SUMMARY

# RESOLUTION NO. 85-633

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

AUGUST 20, 1985

APPROVING FINAL MAP FOR VILLA ROYALE UNIT NO. 2 (P-84-237)

WHEREAS, THE COUNCIL OF THE CITY OF SACRAMENTO FINDS AND DETERMINES AS FOLLOWS:

- 1. The final subdivision map of <u>Villa Royale Unit No. 2</u>, together with provisions for its design and improvement, is consistent with the General Plan of the City of Sacramento and the 1968 Valley Hi Community Plan.
- 2. The final map is in substantial compliance with the previously approved tentative map.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO AS FOLLOWS:

- a. The final map of <u>Villa Royale Unit No. 2</u>, be, and the same is hereby approved subject to the execution by all parties of an agreement whereby the Subdivider will participate in any future assessment district to install improvements.
  - b. All offers of dedication shown on said map are hereby accepted.
- c. The City Manager and City Clerk be authorized and directed to execute on behalf of the City of Sacramento that certain Agreement between the City and Lawrence J. Mailliard. Said agreement requires that the present owner and any successors in title will participate in any future assessment district that affects said Subdivision Map, thereby waiving their right to protest.
- d. The Real Estate Supervisor is authorized and directed to record the Agreement in the official records of Sacramento County.
