SUBJECT: Resolution Authorizing the Transfer of Surplus and Obsolete Material and the

Transfer of Surplus and Obsolete Traffic Signal Equipment to Safety Center

of California for "Safetyville"

SUMMARY

The City of Sacramento staff has worked with officials of the Sacramento Safety Council in the development of the "Safetyville" Center. Surplus and obsolete traffic signal equipment is available that can be utilized for this worthwhile project.

Since the City Council holds title to this equipment, it is necessary for the Council to approve this transfer.

BACKGROUND INFORMATION

During the development of the "Safetyville" Center by the Sacramento Safety Council, various members of the City staff from Traffic Engineering Division provided technical input. "Safetyville" is a miniature city where youths will have a scaled down city to travel and be instructed in various safety areas. It is located adjacent to the Safety Council facilities on Bradshaw Road.

Recently a traffic consultant firm took over the design work for the project and approached Street Maintenance regarding the availability of traffic signal equipment. After reviewing the needs of "Safetyville" we found there was certain surplus and obsolete equipment that the City could provide that could help achieve the goal of traffic safety training for the youth of the Sacramento area.

Local contractors are donating their time, and they are providing the underground installation of conduits as well as the bracket arm and the mast arm standard base installation. They will also be doing all of the wiring and related electrical work with the City of Sacramento providing material only as previously mentioned if approved by the City Council.

FINANCIAL

The City will be providing two obsolete controllers with cabinets that have no value at this time. Also, we will be providing four mast arm standards and four bracket arm standards with vehicular and pedestrian heads. The estimated value for all of the equipment is under \$10,000.
