2. Presentation on Bike Access to K Street Mall by Chris Dougherty, Associate Planner, City Department of Transportation.

**Recommendation:** Review and comment or provide direction on the creation of an ordinance and guidelines allowing bicycles to operate safely on K Street.

**Contact**: Chris Dougherty, Associate Planner, (916) 808-5680, City Department of Transportation.

**Discussion:** Chris Dougherty updated the Commissioners on the Bike Access to K Street Mall. He focused on two main concerns raised by the Commissioners during the August 20<sup>th</sup> 2009, presentation to DAC. The concerns are: (a) cross walk treatment and (b) separated bike lane on the tunnel leading to Old Sacramento. Staff reported that the cross walk options are being studied, but the idea of designated and separate bike lane on the tunnel is problematic.

In light of this, two motions were put forward by the Commissioners. The first motion was to recommend that bikers dismount as they transverse through the tunnel.

Motion **passed** to recommend that bicyclist dismount their bikes as they transverse through the tunnel leading to and out of Old Sacramento.

Staff reminded the Commissioners that the existing City Ordinance already prohibits bike ride through the tunnel.

The second motion was to recommend to the City Council that the bicycle ordinance not be adopted.

# 3. Presentation on K Street Vehicle Traffic Study by Ed Williams, Project Manager with City Department of Transportation.

**Recommendation:** Review and comment or provide direction on allowing cars to operate safely on K Street.

Contact: Ed Williams, Project Manager, (916) 808-8288, City Department of Transportation.

**Discussion:** Ed Williams presented the K Street Vehicle Study. He indicated that the City is proposing a "pilot program" to allow cars to operate within two blocks of K Street Mall. The two blocks in consideration are 12<sup>th</sup> to 10<sup>th</sup> or 10 to 8<sup>th</sup>. Staff indicated that the 12<sup>th</sup> to 10<sup>th</sup> scenario may pose greater conflicts due (a) location of Regional Transit (RT) platforms, (b) less concentrated business to benefit from the program. Mr. Williams said that staff would be going to City Council to ask for direction to move forward with the pilot project in late October of 2009. The Commissioners and the public in attendance had several probing questions. The questions focused on the following (a) safety of pedestrians, (b) how to mitigate conflicts between trains, cars, bicyclist and pedestrians, (c) Regional Transit (RT) schedule and safety of patrons boarding and disembarking of light rail.

In light of this, two motions were put forward by the Commissioners. The first motion was to recommend to the City Council that DAC opposed re-introducing cars on K Street Mall.

Motion did **not pass**. The chair stated that the Commission took no position on whether to support staff proposal to ask for direction from City Council to move forward with the "pilot project" to re-introduce cars on segment of K Street Mall (12<sup>th</sup> to 10<sup>th</sup> or 10 <sup>th</sup> to 8<sup>th</sup>).

Rocky volunteered to compile the concerns expressed by the disability community and members of the Disabilities Advisory Commission and have them distributed by staff to DAC. The Commission would review and comments. DAC would provide input as to how these concerns could be resolved or not.

It was also agreed that a field trip with DAC would be conducted by staff to discuss the proposed project blocks under consideration (12<sup>th</sup> to 10<sup>th</sup> or 10 to 8<sup>th</sup>). The field trip is tentatively planned in October.

Staff updated the Commissioners on Current Accessibility Programs and Activities, including the status of future Agenda items:

- (a) Reasonable Accommodation Ordinance [LR09-001], presented to DAC on couple occasions, by Greg Sandund, Assistant Planner, with City Planning Department, was adopted by Council on August 25, 2009.
- (b) Draft Universal Design Ordinance is slated to come before the DAC on October 15, 2009. The presentation would be by Greg Sandund, Assistant Planner, with City Planning Department.
- (c) The Alley Activation project was approved by City Council on August 11, 2009. Council directed staff to continue to work with project team. The project team has not confirmed their presentation to DAC. Staff would follow up.
