Audit of the Sacramento Police Department (SPD): Misconduct Complaint Cases

Under the direction, control and supervision of the City Council, the Director **shall** have the following authority and responsibility as related to the <u>Sacramento Police Department</u> and <u>Sacramento Fire Department</u>:

2.22.030 Duties and functions of office.

The Office shall:


- A. Audit all complaint investigations of the police department and fire department, as the director deems necessary.
- B. Monitor all complaint investigations conducted by the police department and fire department.
- C. Request the police department and fire department perform further investigation in those complaint cases that require additional investigation as determined by the director.
- D. Receive all documents, reports, or any other item necessary to monitor or audit a complaint investigation.
- E. Assist the city council, or any duly appointed committee of the council, in performing its investigative functions under section 34 of the charter.
- F. As needed, request the city council, or any duly appointed committee of the council, to issue subpoenas as provided in section 34 of the charter. The city council may, by resolution, establish the procedures for the request, issuance, and service of those subpoenas.
- G. Perform such other inquiries and investigations as prescribed by council resolution.
- H. Accept and document complaints directly from citizens as an alternative procedure for citizen complaints concerning public safety personnel, using a complaint form distinct from that used by the police department or fire department. All such complaints shall be promptly forwarded to the respective public safety department for investigation.
- I. Provide complainants with timely updates on the status of investigations, excluding disclosure of any information that is confidential or legally protected.
- J. Explain how the complaint process works to all complainants.




- Ascertain whether there is a systemic problem or isolated incidents in SPD reference officers engaging in pattern or practice of unreasonable stops, searches, and seizures violating community members' Fourth Amendment rights, specifically Black and Latino community members
- Review of 109 completed misconduct complaint cases

SPD Case Dispositions





Types of Violations: SPD Sustained Case Violations




Complaint Demographics: Complainant's Age & Gender




Complaint Demographics: Complainant's Race






Complaint Demographics: Complaints by Council District


Key Findings & Recommendations: **Finding One**

Stops Based on Minor Traffic Infractions Such as Improper Window Tint with No Apparent Intention to Enforce the Vehicle Code or Ticket the Driver Amount to Pretextual Stops

Recommendations

- Eliminate the practice of pretext stops or set clear restrictions on conducting them
- Develop a clear policy for conducting traffic stops


Complaint Demographics: Type of Police-Citizen Interaction

Key Findings & Recommendations: **Finding Two**

SPD Does Not Have a Current, Stand-Alone Policy Regarding the Fourth Amendment and Includes Search and Seizure

Recommendations

- Draft a clear and stand-alone policy
- Update SPD search and seizure manual from 2007



Key Findings & Recommendations: Finding Three

Automatic Pat Downs of Citizens are in Direct Conflict with the 1968 United States Supreme Court Decision, *Terry v. Ohio*

Recommendations

- Require officers to articulate why a citizen was stopped and why a pat down of the person was warranted in their reports
- Draft a clear policy on pat downs, investigatory stops, and investigative detentions
- Ensure continuous training to new recruits and police officers on investigatory stops, pat downs, reasonable suspicion, and Fourth Amendment fundamentals, in accordance with newly issued policy



Key Findings & Recommendations: **Finding Four**

Warrantless Entry into Citizens' Homes and Conducting Searches without Sufficient Legal Authority

Recommendations

- Draft a policy for conducting welfare checks that encompass warrantless entry into citizen's homes



Key Findings & Recommendations: Finding Five

Internal Reviews by Supervisors do not Consistently Identify Fourth Amendment Violations

Recommendations

- All misconduct complaint cases investigated by IAD & supervising personnel within assigned divisions must be investigated impartially and thoroughly
- All personnel need to receive the supplemental search and seizure training from Sacramento District Attorney's Office

Audit Summary



Audit Limitations

- Limited scope
- Office capacity
- Dependence on internal complaint information only
- Excludes incidents that were not reported by community members
