SUBJECT: Resolution Approving Petition For Florin Road Storm and Sanitary Sewer Assessment District, Improvement Proceeding No. 4622

SUMMARY

Adoption of a Resolution rescinding a prior petition and approving a new petition for Florin Road Storm and Sanitary Sewer Assessment District - (I-5 and Florin Road)

BACKGROUND INFORMATION

On September 7th, 1976, the City Council approved a petition for Florin Road Storm and Sanitary Sewer Assessment District, Improvement Proceeding No. 4622. This proceeding has been delayed over the years for one reason or another and the parties who signed the original petition no longer own the property.

We therefore requested the current owners to sign a new petition requesting the improvements which is being submitted for your approval.

FINANCIAL DATA

The cost of the improvements will be assessed against the property with no City funds being involved.

RECOMMENDATION

It is recommended that the following Resolutions be adopted in the order listed below which rescinds the original petition and approves a new petition. It is also recommended that the area described in the petition be referred to hereafter as Florin Road Storm and Sanitary Sewer Assessment District.

RESOLUTION APPROVING PETITION

FOR IMPROVEMENT PROCEEDING NO. 4622

**FLORIN ROAD STORM AND SANITARY SEWER
ASSESSMENT DISTRICT**

WHEREAS, a petition has been filed with the City Council requesting that proceedings be adopted for the improvement of

FLORIN ROAD STORM AND SANITARY SEWER ASSESSMENT DISTRICT,

in the City of Sacramento; and

WHEREAS, the signers of said petition state that they are all of the Owners of more than 60% of the area liable for Assessment for said work and improvement, and they expressly "WAIVE" the provisions of Division 4 of the "Streets and Highways Code of the State of California" (The Special Assessment Investigation, Limitation and Majority Protest Act of 1931), as amended, and all investigations, proceedings and reports provided for therein; and

WHEREAS, the said petition has been checked by the City Engineer's Office and found that the WAIVER is signed by the Owners of more than 60% of the area liable for Assessment for said work.

NOW, THEREFORE, BE IT RESOLVED by the City Council that the said petition is hereby approved and granted; and

BE IT FURTHER RESOLVED that the City Council hereby finds and determines that the WAIVER in said petition is signed by the Owners of more than 60% of the area liable for said work and improvement and hereby directs that proceedings for said work be authorized, as provided in Division 7 of the said Streets and Highways Code, THE IMPROVEMENT ACT OF 1941.
