SUBJECT: Resolutions Continuing Salaries and Benefits Pursuant to the Current Agreement with American Federation of State, County and Municipal Employees (AFSCME), Local 146, Beyond the Expiration Date of December 24, 1982

### SUMMARY

The agreement between American Federation of State, County and Municipal Employees, Local 146, and Sacramento Housing and Redevelopment Agency expires on December 24, 1982. Therefore, since a new agreement cannot be reached and approved by December 24, 1982, it is requested that salaries and benefits pursuant to the current agreement be continued. In the event agreement is reached by December 24, 1982, staff will return to the Governing Board on January 4, 1983 with the agreement which will be retro-active to December 25, 1982.
