Subject: Supplemental Agreements for Building Plan Review Services

Location/Council District: Citywide

Recommendation: Staff recommends that the City Council adopt the attached **Resolution** 1.) reallocating to the Development Services Department FY2006-07 operating budget \$30,680 from a FY2004-05 liquidated purchase order; 2) approving supplemental professional service agreements for plan review services with Buehler & Buehler in the Not To Exceed (NTE) amount of \$101,000; Cole, Yee, Shubert in the NTE amount of \$84,000; Cornerstone in the NTE amount of \$28,000; McKenny Krug in the NTE amount of \$7,000; Mike Anderson Engineering in the NTE amount of \$64,000; Plan Review Consultants in the NTE amount of \$90,000; and Shuhaibar in the NTE amount of \$44,000; 3) approving a supplemental professional service agreement for engineering services with Woods & Associates in the NTE amount of \$12,000; 4) approving supplemental professional service agreements for fire plan review services with Brown & Associates in the NTE amount of \$35,000 and Greg Ledesma in the NTE amount of \$56,000; 5) approving supplemental professional service agreements for inspection services with 4 Leaf Consultants in the NTE amount of \$153,000; Berryman & Henigar in the NTE amount of \$50,000 and Wildan in the NTE amount of \$57,000; 6) authorizing the City Manager to execute such supplemental agreements.

Description/Analysis

Issue: Staff recommends execution of contract supplements with plan review and inspection consultants totaling \$781,000. These supplemental agreements will be funded by the reallocation of funding from a liquidated prior year purchase order and the Development Services FY2006-07 operating budget.

Policy Considerations: This request to adopt the attached resolution is in accordance with the policy recommended by the Development Oversight Commission to contract out workload that cannot be performed by City

employees. Additionally, it is consistent with all four of the City Council's three-year goals from the Strategic Plan.

Commission/Committee Action: None

Environmental Considerations: There are no environmental considerations associated with this report.

Rationale for Recommendation: The use of professional services contracts for consultants and temporary inspection services provides flexibility in meeting service demand levels. In addition, these professional service agreements will allow the Department to maintain adequate service levels in plan review and inspection services for FY2006-07.


Financial Considerations: The total of all increases in the supplements total \$781,000. The Development Services FY2006-07 operating budget will fund \$750,320 of these supplemental agreements. The balance of \$30,680 will be funded by the reallocation of a liquidated purchase orders from FY2004-05. This purchase order was funded by revenue received from plan review fees paid by applicants and is therefore an appropriate use of prior year funds.


The need for consultant support for plan review and inspection services is anticipated to be lower than prior fiscal years. Therefore, the supplemental agreements amount have been lowered accordingly.

RESOLUTION APPROVING SUPPLEMENTAL PROFESSIONAL SERVICE AGREEMENTS FOR INSPECTION SERVICES PLAN REVIEW SERVICES, AND BUILDING AND FIRE PLAN REVIEW SERVICES AND AUTHORIZING THE CITY MANAGER TO EXECUTE SUPPLEMENTAL AGREEMENTS

BACKGROUND

- A. The use of professional services contracts for consultants and temporary inspection services provides flexibility in meeting service demand levels.
- B. Professional services allow the Development Services Department to maintain adequate service levels in plan review and inspection services for the FY2006-07.
- C. The Development Services Department desires to make efficient use of existing and prior year funding sources for the supplemental agreements.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. Liquidate one FY2004-05 building consultant purchase order for \$30,680.
- Section 2. Reallocate to the Development Services FY2006-07 operating budget the liquidated purchase order in the amount of \$30,680.
- Section 3. Supplemental consultant and professional service agreements with Buehler & Buehler in the Not To Exceed (NTE) amount of \$101,000; Cole, Yee, Shubert in the NTE amount of \$84,000; Cornerstone in the NTE amount of \$28,000; McKenny Krug in the NTE amount of \$7,000; Mike Anderson Engineering in the NTE amount of \$64,000; Plan Review Consultants in the NTE amount of \$90,000; Shuhaibar in the NTE amount of \$44,000; and Woods & Associates in the NTE amount of \$12,000 for plan review services are approved.
- Section 4. Supplemental consultant and professional service agreements with Brown & Associates in the amount of \$35,000 and Greg Ledesma in the NTE amount of \$56,000 for fire plan review are approved.

Section 5. Supplemental consultant and professional service agreements with 4 Leaf Consultants in the NTE amount of \$153,000; Berryman & Henigar in the NTE amount of \$50,000 and Wildan in the NTE amount of \$57,000 for inspection and plan review services are approved.

Section 6. The City Manager is authorized to execute such approved agreements.
