SUBJECT: Hearing on Assessment, Improvement Proceeding No. 5094, Del Paso Heights Assessment District No. 4B

#### SUMMARY

The object of the Hearing is to hear any protests against the Assessment District and to confirm the Assessment.

#### BACKGROUND INFORMATION

The City Engineer filed the Assessment for Improvement Proceeding No. 5094, Del Paso Heights Assessment District No. 4B, with the City Clerk on December 22nd, 1981. The improvements constructed under this proceeding consist of concrete curb, gutter and sidewalk, asphaltic concrete pavement, storm sewers, drainage facilities, remove and replace sanitary sewers, reconstruct sanitary sewer manholes, water distribution system complete and street lighting system complete, together with all necessary appurtenances, as described in the Resolution of Intention adopted by the City Council on March 31st, 1981. The City Clerk mailed a Notice of Filing Assessment to each property owner on December 22nd, 1981 and published said Notice in the Daily Recorder on December 24th and 28th, 1981.

### FINANCIAL DATA

This project is being financed jointly by the property owners within the district and the City of Sacramento. The City's Contribution is \$484,540.62 and is to be funded from Community Development Block Grant Fund, 2-07-2600-2702-4820, in the amount of \$466,540.62 and Sewer Fund, 4-14-2600-2702-4820, in the amount of \$18,000.00. The balance of the cost, \$166,813.65, is to be assessed against the property owners.

# RECOMMENDATION

As no protests have been received, it is recommended that the attached Resolution Approving Assessment be adopted.

WHEREAS, this Council, upon the recommendation of the Superintendent of Streets being satisfied with the correctness of said Assessment, Diagram and Engineer's Certificate, hereby finds and determines that said Assessment, Diagram and Engineer's Certificate are true and correct in all respects as filed.

IT IS HEREBY RESOLVED that this Council has heretofore adopted it's Engineer's Report and the same is attached hereto and marked Exhibit "A" and incorporated by reference herein; and that said Assessment, together with the Diagram and Engineer's Certificate attached thereto, be, and the same are hereby confirmed and approved in all respects as filed. IT IS HEREBY FURTHER RESOLVED that this Council finds that each parcel of land within the assessment district receives a special benefit from the improvements constructed in this proceeding and that each parcel of land within the district is increased in value by reason of said improvements.

NOTICE OF DECISION and FINDINGS OF FACT JAN 1 2 1982

At its regular meeting of December 1, 1981, the City Council heard and considered evidence in the above entitled matter. Based on oral and documentary evidence at said hearing, the Council denied the appeal and upheld the decision of the Planning Commission based on the following findings:

- 1. The four-foot landscaping strip along the southern property line is based on sound principles of land use in that it will provide a landscaping buffer to the adjacent residential dwellings to the south.
- 2. The landscaping will not be detrimental to the public health, safety or surrounding properties in that it will help reduce the visibility of the recreation vehicles from the dwellings located to the south.
- 3. The landscaping requirement is consistent with the policies of the 1974 General Plan which encourages neighborhood beautification and discourages the intrusion of undesirable uses into residential neighborhoods.
