**SUBJECT: Citation and Arrest Authority**

**SUMMARY**

The attached resolution amends Resolution 89-866, which specifies employees within the Department of Planning and Development, Neighborhood Services Division, be granted citation and arrest authority pursuant to Ordinance 85-033. Adoption of the resolution is necessary due to personnel changes.

**BACKGROUND**

Ordinance 85-033, changed the way citation and arrest authority was granted to certain employees by eliminating the "Special Police Officer" classification. The Ordinance requires the City Manager to submit a list of persons to be granted citation and arrest authority to the City Council. The Council will grant citation and arrest authority by resolution.

The granting of citation and arrest authority has no fiscal impact.
