**Title:** Construction Contract: Two Rivers Trail, Phase I, CIP HB66

**Location/Council District:** American River Parkway's South Levee / Council District 1

**Recommendation:** Adopt a **Resolution:** 1) Accepting Biondi Paving as the low, responsible bidder for Two Rivers Trail, Phase I, CIP HB66; and 2) Awarding the construction contract to Biondi Paving in the amount of \$653,329 for Two Rivers Trail, Phase I, CIP HB66.

## Description/Analysis

**Issue:** The Department of Parks and Recreation is responsible for the development of off-street recreation trails. The Two Rivers Trail is an important part of a regional trail system that offers both recreation and commuter opportunities.

The formal bid process for Phase I of the Two Rivers Trail project has been completed and a construction bidder has been selected based on the qualifications set forth by the City. A summary of the Two Rivers Trail project history is included as Attachment 1 (page 4) and a location map as Attachment 2 (page 5).

**Policy Considerations:** City Code Chapter 3.60 identifies the general guidelines for completing contracts for public projects and procedures for bidding and issuing contracts over \$100,000.

Providing parks and recreation facilities is consistent with the City's strategic plan to enhance liveability in Sacramento's neighborhoods by expanding park and recreation facilities throughout the City.



**Environmental Considerations:** The action of approving agreements between two regulatory agencies to protect natural resources is exempt under California Environmental Quality Act (CEQA) Guidelines Section 15307 which states that actions taken by regulatory agencies as authorized by state law or local ordinance to assure the maintenance, restoration, or enhancement of a natural resource where the regulatory process involves procedures for protection of the environment is exempt. No construction activities are involved in this exemption.

Any further actions requiring construction under the agreements have been adequately analyzed within the Negative Declaration for the Two Rivers Trail project approved on November 8, 2005, by the Director of the Department of Parks and Recreation. Mandatory mitigation measures, as specified in the Mitigation Monitoring Plan, have been incorporated into the project plans to avoid identified impacts or to mitigate such impacts to a point where clearly no significant impacts will occur.

**Rationale for Recommendation:** The formal bidding process for this project was posted in accordance with City Code 3.60 and Policy (API 48). The project was posted and the bids were opened on June 7, 2006. Staff received four bids and the results are listed below; as per City Code 3.60.020, it was determined that Biondi Paving was the responsible, low bidder with the base bid and additive alternate #1 (rubberized paving) bid of \$653,329.00.

**Financial Considerations:** No new funds are requested for this report. There are sufficient funds in CIP HB66 to award the construction contract. This \$2.095 million budget has received funds from the General Fund (\$510,000), Transportation Development Fund (\$35,000), Railyards/Richard/Downtown Impact Fund (\$50,000), and Proposition 40 River Parkway Program, Fund 248(\$1.5 million).

**Environmental Considerations:** The California Environmental Quality Act (CEQA) documentation, right-of-way engineering, and the survey work on Phase I is completed. On November 8, 2005, the Department Director approved the Negative Declaration for the development of Two Rivers Trail. The Environmental Services Manager has determined that the action of approval of the paving construction for Phase I does not require further environmental evaluation, as it falls within the scope of the Negative Declaration. Mandatory mitigation measures, as specified in the Mitigation Monitoring Plan, have been incorporated into the project plans to avoid identified impacts or to mitigate such impacts to a point where clearly no significant impacts will occur.

**Rationale for Recommendation:** The formal bidding process for Phase I of the Two Rivers Trail project was posted in accordance with City Code 3.60 and Administrative Policy Instruction #48. The project was posted and the bids were opened on June 7, 2006. Staff received four bids and the results are listed below; pursuant to City Code Section 3.60.020, it was determined that Biondi Paving was the responsible, low bidder with the base bid and additive alternate #1 (rubberized paving) bid of \$653,329.00.

**Financial Considerations:** No new funds are requested for this report. There are sufficient funds in CIP HB66 to award the construction contract.

**Emerging Small Business Development (ESBD):** The selection of contractors for this project followed City-established guidelines for inclusion of ESBD firms. At an SBE/EBE percentage total of 30.9%, Biondi Paving and its subcontractors exceed the City's required 20% ESBD rate.

## Attachment 1

### Background Information

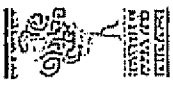
The Two Rivers Trail project consists of two trail segments on the American River Parkway's South Levee that offer a connection from Tiscornia Park to the Sutter's Landing Regional Park. This is planned as a Class I bike trail approximately 2.5 miles in length and located primarily on the crown of the American River's southern levee. Phase I of the trail is approximately 1.75 miles and runs from Tiscornia Park to Highway 160.

This trail is an important element of the redevelopment in the Richard's Boulevard area and will also connect the Sacramento River Parkway to the American River Parkway, increasing alternative transportation access to downtown employment and economic centers.

The County of Sacramento owns parcels in-fee and recreation easements along much of the alignment of Phase I of the Two Rivers Trail; the County of Sacramento has agreed to let the City of Sacramento use its real estate interests through a use agreement and a lease agreement. The agreements with the County of Sacramento will allow the trail and parkway to continue development.

All property interests necessary for completion of the Two Rivers Trail have been, or currently are being, acquired.

Construction of Phase I of the Two Rivers Trail project is expected to be completed by November of 2006.

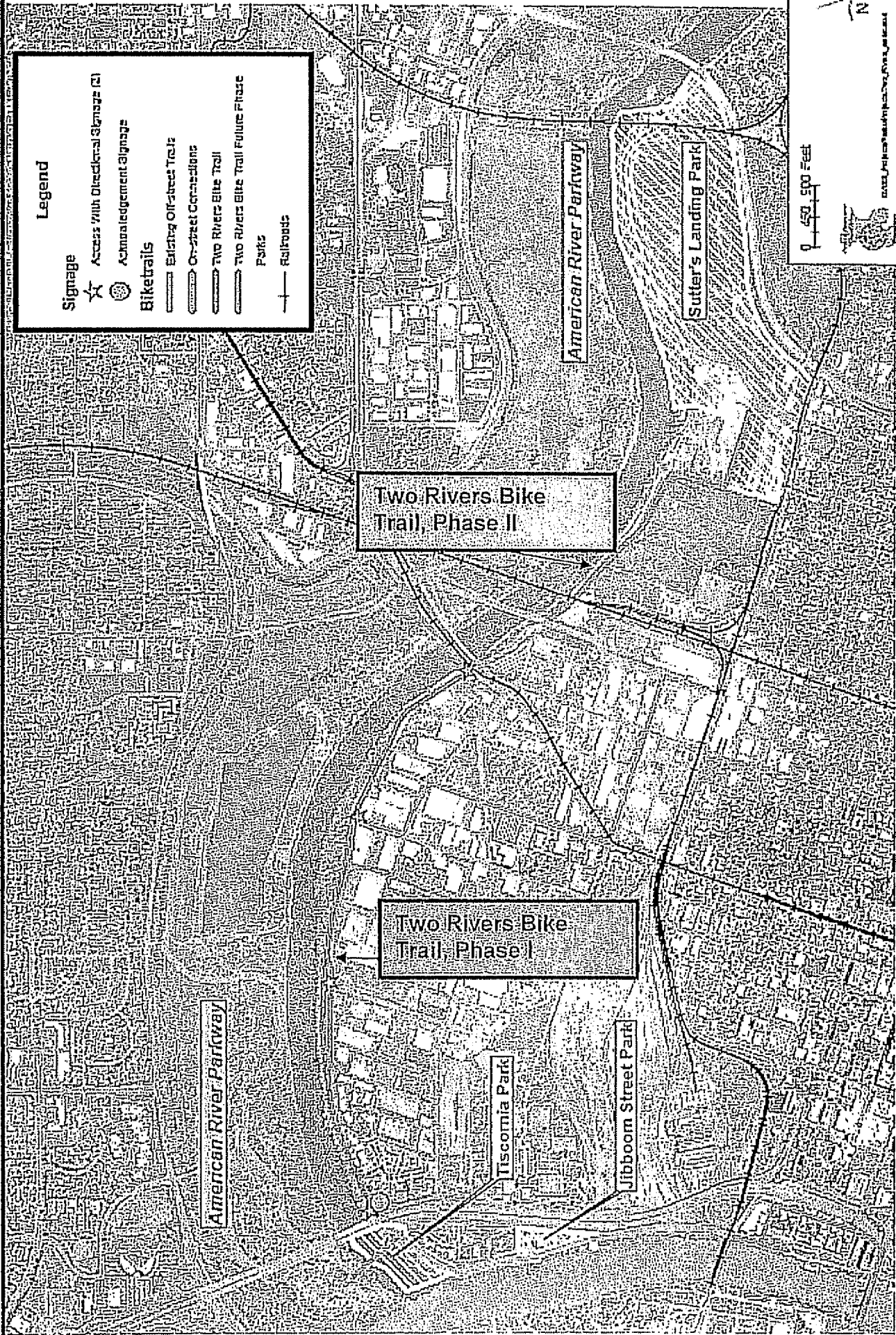

**CONSTRUCTION CONTRACT: TWO RIVERS TRAIL, PHASE I, CIP HB66**

**BACKGROUND**

- A. The Two Rivers Trail is an important part of a regional trail system that offers both recreation and commuter opportunities. Two Rivers Trail runs primarily on the crown of the American River's southern levee from Tiscornia Park to the Sutter's Landing Regional Park; Phase I runs from Tiscornia Park to Highway 160.
