SUBJECT: Approval of Parcel Map Agreement (P-8637)

BACKGROUND INFORMATION

On July 10th, 1979, the Council adopted Resolution No. 79-457 which approved a tentative parcel map for Airport Road and San Juan Road for property owned by Frank D. Machado and Olga W. Machado. A condition of approval of this tentative map was that the Machados enter into an agreement with the City to participate in and assist in the formation of any proposed assessment district which might be formed to construct improvements involving their property. This agreement is being presented for approval at this Council meeting.


