SUBJECT: Recreation Division - Authorization to Submit Grant Application Under the 1981-82 Cultural and Civic Awards Program, County of Sacramento

SUMMARY

This report recommends authorization for the Recreation Division to submit a grant application to the County of Sacramento, 1981-82 Cultural and Civic Awards Program in the amount of NINE THOUSAND DOLLARS (\$9,000) for the purpose of conducting a South Area Neighborhood Mural Project.

BACKGROUND INFORMATION

Annually the County of Sacramento allocates monies to the Community Cultural and Civic Arts groups for the purpose of improving the quality of life through the arts and other civic programs.

This grant will provide funds for a South Area Neighborhood Mural project. The project will be integrated into existing recreation and educational programs in the Woodbine, Mark Hopkins and Argonaut communities.

Basically the project will involve local community residents and school children in the design and painting of murals on neighborhood park facilities. The project will be coordinated by the Recreation Division with assistance from the Sacramento City Unified School District and Centro de Artistas Chicanos. Artists from the local community will be commissioned to conduct and oversee the project.

FINANCIAL DATA


The grant does not require additional City or County funds. However, a match is required in funds other than State monies. The Recreation Division intends to match the grant amount through in-kind contributions.

RECOMMENDATION


