MEMORANDUM

SUBJECT: TRAFFIC TICKETS ISSUED AT 5571 - 79TH STREET TO  
MR. HENRY HAYES

Mr. Henry Hayes contacted the Mayor, Councilmember Smallman, and the City Manager's Office on several occasions. He alleges he is being harassed by the Police Department who advised him to move his truck which they said was illegally parked. Mr. Hayes refused and was ticketed twice. He alleged that the area in which the truck was parked was not posted "No Parking".


Mr. Hayes resides at 5517 - 79th Street which is near the corner of Fruitridge and 79th Streets. He had parked his vehicle on the Fruitridge side while remodeling his home to facilitate loading residual material from the remodeling into his truck which would then be taken to the dump.

Mr. Hayes appeared at the December 16, 1986 Council meeting and addressed the Council on this issue. Staff was instructed at the Council meeting to investigate the area for proper signage. If proper signage did not exist, then appropriate action would be initiated and steps would be taken to post the area "No Parking".

This matter was investigated by staff and they did not find proper signage. It is hereby requested that you have the tickets invalidated. Copies of the tickets are attached.
