SUBJECT: SEMIANNUAL WEED ABATEMENT HEARING

SUMMARY

This report recommends that the City Council adopt the attached resolution which establishes 7:30 p.m., July 28, 1987 in the City Council Chambers, 915 I Street, Sacramento, California as the time, date, and place for hearing protests, if any, for weed abatement work performed in the spring of 1987.

BACKGROUND

City Council Resolution No. 86-764, adopted October 7, 1986, declares the City Council's intent for staff to bill semiannually for weed abatement work performed. The resolution also states that the City Council will conduct a lien hearing for the unpaid billings approximately thirty days after the bills are mailed.


DISCUSSION
