SUBJECT: Appeal of Charles A. Martin from the decision of the City Manager's Office regarding a Dance Permit Denial

SUMMARY

Attached is the appeal of Charles A. Martin from the decision of the City Manager's Office; Dance Permit Denial, as required by Section 13.64 of the Sacramento City Code.

BACKGROUND

Under Sections 2.323 and 2.324 of the City Code, the Council may appoint a hearing examiner to hear the appeal if it finds that "the appeal may involve a lengthy factfinding process which would be more appropriately accommodated by a formal hearing before a hearing examiner."

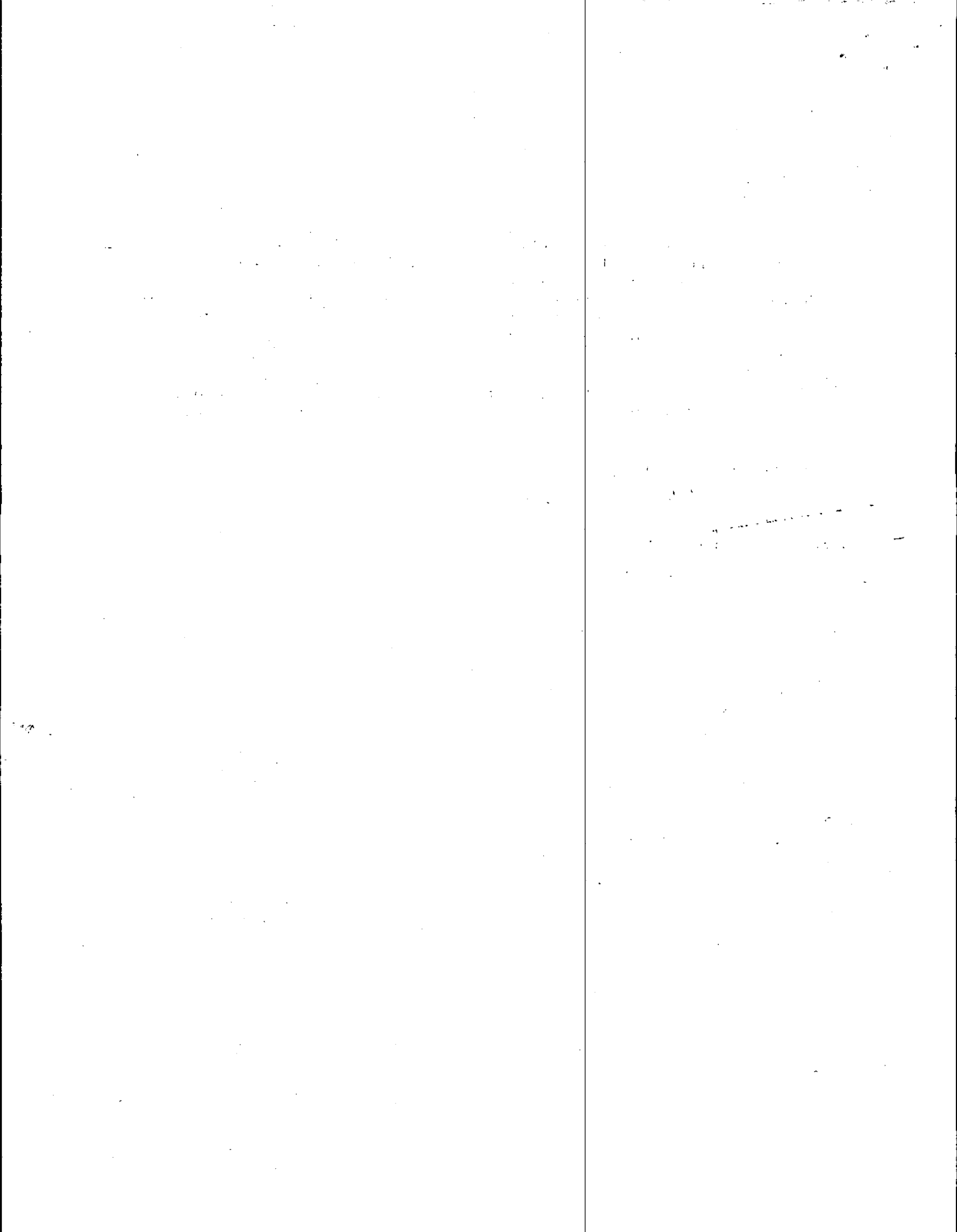
