SUBJECT: Suspension of Formal Competitive Bidding for the Purchase
of Two 2-Ton Trucks with Utility Bodies

SUMMARY

The Equipment Maintenance Division has a requirement for the purchase of two 2-ton trucks with utility bodies identical to the ones awarded by the City Council to the F. B. Hart Company on June 24, 1979 (Purchase Order Number 48009). Since the F. B. Hart Company is offering to supply two additional vehicles at the same unit price (\$15,460 plus sales tax), it is recommended that the City Council suspend formal competitive bidding for this requirement.

BACKGROUND INFORMATION

The following is a bid tabulation of the four bids received on June 10, 1980 (bids were mailed to fifteen potential vendors known to furnish similar types of vehicles):


FINANCIAL DATA

RECOMMENDATION


