Honorable Members in Session:

SUBJECT: Status of SHRA Efforts to Distribute Surplus Cheese

On December 23, 1981, Agency staff contacted both the State Health and Welfare Agency as well as the Senior Gleanors to facilitate the distribution of FDA Surplus Cheese to the poor persons of the Sacramento community. Although the Agency is ineligible to participate because it lacked non-profit status, the staff was able to obtain 4200 pounds of cheese through the assistance of Mrs. Leona Miller, President of the Dos Rios Tenant Council. The following is the status of cheese distribution by this Agency.

#### I. Family Units

On Christmas Eve, December 24, 1981, through the support of the Resident's Committee, the Dos Rios Housing Unit received 22 cases for their 261 residents.
